

## Minutes of The 6<sup>th</sup> meeting of State level Environment Impact Assessment Authority ,Jharkhand held on dated 25/07/2013

The 6<sup>th</sup> meeting of the State Level Environment Impact Assessment Authority was convened on 25/07/2013 at the Authority's office. The meeting was Chaired by Dr. Gurdeep Singh, Chairman, SEIAA. The following members attended the meeting:

The following issues were discussed in the meeting:-

- A. Deed of lease of the office premises of SEIAA & SEAC approved by the Authority. Legal opinion of Govt. Advocate to be obtained regarding the lease deed. Registration of the agreement to be done as per the legal provision .
- B. Decision to engage Mr. A.K. Pandey as a legal consultant on case to case basis and consultation fee will be paid as per prevailing Govt. rates.
- C. Minutes of the meeting of SEIAA, Jharkhand held on June 14, 2013 were confirmed.
- D. The recommendations of the proposals by SEAC were discussed and following decisions were taken :

1. **M/s. Raj Kumar Khurana, Vill - Munker, Tehsil - Chatarpur, Dist - Palamu, Jharkhand (Area 4.047 Ha).**

SEAC examined the proposal and recommends to SEIAA for consideration for issue of EC.

SEIAA agrees to the recommendation.

2. **M/s. Radha Krishna Jaiswal, Vill - Leungdih, Dist - Sarikela-Kharsawan, Jharkhand (Area 23.5 acres i.e. 9.5 Ha).**

7. **Stone Quarry of M/s. Express Infratech Pvt Ltd. at Village Chandradeepa, Mouja Mihijam Dist – Jamtara Jharkhand (Area 5.08 Ha).**


Noted the observation of SEAC. Project falls at a distance of 8.5 km from inter – state boundary - West Bengal i.e. within 10 km of inter – state boundary as per EIA Notification 2006, any project or activity specified in Category 'B' will be treated as Category 'A', if located in whole or in part within 10 km from the boundary of inter-state.

Proposal will be referred to MoEF, New Delhi. for consideration for grant of EC.

8. **Purandihi Stone Mines of M/s. Jay Durga Stone Works. at Village Purandihi, Tehsil – Markacho, Dist – Koderma Jharkhand (Area 0.211 Ha).**

On receipt of the necessary information from PP, SEAC may consider the same and forward for necessary recommendation to SEIAA.

13. **Stone Mining Project of M/s Shree Balaji Enterprises at Village Ichadag , P.O. Ormanjhi, Dist – Ranchi Jharkhand (Area 4.86 Ha – 12 acres).**

19. **Borrow pits of M/s Madhucon Projects Limited which are located on both sides of Road alignment spread over Dist – Ranchi and East Singhbhum, Jharkhand (Total area 177.34 Ha for mining of 5.00 Million cu.m.of clay and soil).**
