

Minutes of The 7th meeting of State level Environment Impact Assessment Authority, Jharkhand held on dated 01/08/2013

The 7th meeting of the State Level Environment Impact Assessment Authority was convened on 01/08/2013 at the Authority's office. The meeting was Chaired by Dr. Gurdeep Singh, Chairman, SEIAA. The following members attended the meeting:

The following issues were discussed in the meeting:-

- A. Minutes of the meeting of SEIAA, Jharkhand held on July 25, 2013 were confirmed.
- B. The recommendations submitted by SEAC on the four(04) of the proposals were discussed and following decisions were taken :

1. **M/s. Radha Krishna Jaiswal, Vill - Leungdih, Dist - Sarikela-Kharsawan, Jharkhand (Area 23.5 acres i.e. 9.5 Ha).**

SEIAA agrees with recommendation of SEAC and grants EC with the general and the specific conditions Additionally PP is to provide the fulfilment of specific requirements of drinking water supply, Medical check-up and treatment facilities, Employment to local people as feasible and WHO recommended Mosquito nets etc. under C.S.R.

The PP will submit the report of C.S.R. per 6 months to SEIAA.

2. **Stone Mining Project of M/s Nitesh Sarda Stone Crusher and Mines at Village Giyarappa, Tehsil Khunti, Dist – Khunti, Jharkhand (Area 2.02 Ha).**

SEAC examined the proposal and recommends to SEIAA for consideration for issue of EC.

SEIAA agrees to the recommendation.

3. **Stone Mining Project of M/s Nitesh Sarda Stone Crusher and Mines at Village Giyarappa, Tehsil Khunti, Dist – Khunti, Jharkhand (Area 0.67 Ha).**

SEAC examined the proposal and recommends to SEIAA for consideration for issue of EC.


SEIAA agrees to the recommendation.

4. **Borrow pits of M/s Madhucon Projects Limited which are located on both sides of Road alignment spread over Dist – Ranchi and East Singhbhum, Jharkhand (Total area 177.34 Ha for mining of 5.00 Million cu.m.of clay and soil).**


SEAC examined the proposal and recommends to SEIAA for consideration for issue of EC.

SEIAA agrees to the recommendation subject to submission of "A separate chapter on the details on mining of soil/earth from borrow areas along with the elaborated EMP to be included in the EIA Report" as stipulated in the order F.No. 2-30/2012-IA-III dtd 18.12.2012 issued by the Director (IA-III), MoEF, GOI within one month failing which the EC will be revoked.

The meeting concluded with vote of thanks to the Chairman.
