- 2. Sl nos. 12 14 of Annexure -1 of 7/5/2013 Guidelines of SEIAA are blank.
- 3. Specifications of equipments have not been provided.
- 4. The water consumption for dust suppression presented by P.P. should be reviewed based on the capacity of production for this unit on realistic basis, and
- 5. EIA/EMP documents are sketchy and there are no data available, which need to be reviewed again.

EC will be considered subject to compliance of the above.
