
SEIAA agrees with the recommendation of SEAC for grant of EC.

14. Tekrahatu Limestone Mine of M/s Shri Banwarilall Newatia, Village Tekrahatu Singhpokharia, Thana- Kolhan , Dist.- West Singhbhum, Jharkhand (Area 9.187 Ha)

SEIAA noted that this is a case of violation and specific undertaking in this regard from the Board /Management of the project proponents is required.

The proposed TORs were examined and approved with certain modifications.

15. Harup Bauxite & Laterite Mine Project of, M/s Shri Girish Kumar Popat, Village Harup, Tehsil Bishunpur, Dist.- Gumla, Jharkhand (Area 45.65 Ha).

SEIAA noted that this is a case of violation and site visit was undertaken by the Subcommittee of SEAC. SEAC is requested to provide the specifics of violation and corrections thereof, so that, TORs can be considered.

16. M/s. Chandra Bhushan, Village Chaparwar, Tehsil - Chatarpur, Dist - Palamu, Jharkhand (Area 6.69 Ha revised to 4.856 Ha).

The proposed TORs were examined and approved with certain modifications.

17. BPCL'S LPG Bottling Plant having 60,000 MTPA Capacity at Village Anandi, Ormanjhi District Ranchi, Jharkhand.

The proposed TORs were examined and approved with certain modifications.

18. Common Effluent Treatment Plant (CETP) at Vill -Shrirampur, Tehsil- Gamharia, Dist-Saraikela-Kharasawan, Jharkhand by M/s Adityapur Auto Cluster.

The generation of hazardous waste from the components of CETP are, not clearly specified in the figure-1 submitted. Further, the ^{second} ~~second~~ landfill facility for disposal of hazardous waste has not been clearly specified. Therefore, the submission of the proponent is not technically complying with the condition vide No. - (c) [letter No.-146, dated 3/10/2013] given earlier for the consideration of the EC. PP may be asked to clarify this condition adequately.

19. City Centre, Village -Asung, Thana-126, Thana- Saraikela , District Kendra Road, City M/s Forum Infrastructure Limited .

Compliance report is not satisfactory. Approval certificate from Ground Water Directorate may also be provided.

20. Construction of the Commercial Complex 'Bokaro Mall' at Sector -3/C, Bokaro , Jharkhand by M/s Amit Reality Pvt.Ltd.

Approval certificate from Ground Water Directorate may be provided.

SEIAA agreed with observations made by SEAC.




SEIAA considered the request regarding the matter.
