

## Minutes of The 11<sup>th</sup> meeting of State level Environment Impact Assessment Authority, Jharkhand held on dated 16/12/2013.

Following issues were discussed in the meeting:-


SEIAA agrees with the recommendation of SEAC for grant of EC.

EC is granted subject to consideration of the sludge from the organic waste water treatment facility as hazardous waste in addition to other four categories mentioned in the compliance letter of PP dated 02/12/2013. The design and operation of the Hazardous waste disposal /management facility should take into account .A compliance report in this regards is sought for within 30 days.

- c) **M/s Mittal Cement's 39600TPA Cement Grinding at Village Rangdih, Tehsil- Govindpur, District Dhanbad, Jharkhand.**


SEIAA agrees with the recommendation of SEAC for grant of EC.


**D.**


a). SEIAA in its meeting held on 07/05/2013 took a decision that Mine Plan will be required for the projects involving less than 5 Ha. land in case of minor minerals .Now the Govt. of India in its memorandum dated 24/06/2013 issued guideline for Mining of Brick Earth .In view of this latest decision, of the MoEF, GOI the requirement of Mine Plan as mentioned in paragraph 6 of the minutes of the meeting held on 7/5/2013 is relaxed for Brick Earth mining.
