(i) Opening Remarks by the Chairman

Prof. (Dr.) A.B. Pandit, Chairman welcomed the Committee members and opened the EAC meeting for further deliberations.

(ii) Details of Agenda items by the Member Secretary

The Member Secretary then apprised the Committee about the details of Agenda items to be discussed during this Expert Appraisal Committee (EAC) meeting.

(iii) Confirmation of Minutes of the 82nd EAC Meeting held on 15-16th July 2024.

The EAC noted that the final minutes of the above meeting were issued after incorporating the comments offered by the members and approved by the Chairman.

Parivesh Portal 1.0

Amendment of EC for addition of adjacent plot for Manufacturing of Synthetic Organic Chemical products (Dyes & Dyes Intermediates) by M/s. Huechem Global (Formerly known as M/s. Laakoona Reactions)

[Proposal No.: IA/GJ/IND3/298667/2023]

The Committee noted that PP has obtained Environmental Clearance from SEIAA vide letter no SEIAA/GUJ/EC/5 (f)/872/2020 dated 7th July, 2020 for setting up of manufacturing unit of 'Synthetic Organic Chemicals at Plot No 56/B-2, Phase -I, GIDC Vatva, Ahmedabad by M/s Laakoona Reactions.

Further PP has submitted application for amendment in EC dated 7th July, 2020 for addition of adjacent plot for Manufacturing of Synthetic Organic Chemical products (Dyes & Dyes Intermediates) in the name of M/s. Huechem Global (Formerly known as M/s. Laakoona Reactions).

The Committee noted that PP has not obtained transfer of the EC dated 7.07.2020 to new company namely M/s. Huechem Global. After detailed deliberation, the Committee desired the following information:

- (i) The Committee suggested to obtained transfer of EC in the name of new company from SEIAA, Gujarat as EC was obtained from SEIAA, Gujarat. Thereafter, PP shall upload the transfer of EC letter to the Pariyesh Portal.
- (ii) The PP needs to submit the action plan with respect to mitigation measures for CPA mentioned in the Ministry's O.M dated 31.10.2019.
- (iii) Land ownership document of new land to be added in the existing unit. PP shall also submit the layout plan of the project area after addition of new land. Reasons for adding new land.

Accordingly, proposal was deferred for want of the above additional information. Above all additional information shall be submitted online to the PARIVESH portal for further consideration by EAC.

Environment Clearance to M/s Asian Paints Limited Ankleshwar for setting up of Integrated manufacturing facility for paints with Resins and Emulsions at Plot No. 2602 to 2607, 2609 to 2614, 2701/A, 2701/B, 2702 and 2703 GIDC Ankleshwar, Dist: Bharuch. In Category 5(h) of Schedule annexed with EIA Notification dated 14.09,2006- Correction in EC

[Proposal No. IA/GJ/IND3/301555/2023; IA-J-11011/278/2023-IA-II(I)]

The PP has requested to issue corrigendum in EC issued by SEIAA vide letter No SIA/GJ/IND2/18342/2017 dated 13.06.2018. While processing the file, it was noted that the proposed corrections are not reflected in the existing EIA report. Further, the PP has corrected the EIA report and uloaded on the Parivesh Portal for corrections in EC.

The Committee noted that correction in the EIA report has been done now. Therefore, this is an amendment case rather than corrigendum. Accordingly, PP shall apply afresh in **Parivesh 2.0 portal** for amendment in EC alongwith requisite information. Since the project is located in the Critically Polluted Area, PP needs to submit the action plan with respect to mitigation measures for CPA mentioned in the Ministry's O.M dated 31.10.2019.

Accordingly, proposal was returned in its present form.
