
SEIAA agrees with the recommendations of SEAC. EC is given with the conditions recommended by SEAC.



SEIAA is not satisfied with recommendation of SEAC. SEIAA in its 17th meeting held on 29.03.2014 made the following observation in this matter-

"SEIAA observed that EIA / EMP Reports generally did not meet the compliance of the TOR's as prescribed particularly w.r.t. Sl. No 6, 7 13, 15-25, 28-33, 35, 37-42.

Environmental Quality Data should be rechecked / redone providing the methodology & instruments used, observations, results of analysis and the detection limits etc.

Modelling input & output data is also required providing how the predicting levels arrived.

Action Plans with Design parameters to control various environmental parameters are also required.

In view of the above, project proponents are required to re-submit the EIA / EMP Reports strictly adhering to the compliance of the TOR's as prescribed. Upon receipt, the same will be forwarded to SEAC for reappraisal."

SEIAA had given ample opportunity to the Project Proponent to explain the matter. However, Project Proponent has not availed the opportunity and did not appear.

SEIAA decided to send the matter back to SEAC to look into it in reference to the observations made by SEIAA and make fresh recommendations.

Environmental Quality Data should be rechecked / redone providing the methodology & instruments used, observations, results of analysis and the detection limits etc.

Modelling input & output data is also required providing how the predicting levels arrived.

Action Plans with Design parameters to control various environmental parameters are also required.

In view of the above, project proponents are required to re-submit the EIA / EMP Reports strictly adhering to the compliance of the TOR's as prescribed. Upon receipt, the same will be forwarded to SEAC for reappraisal."

SEIAA had given ample opportunity to the Project Proponent to explain the matter. However, Project Proponent has not availed the opportunity and did not appear.

"SEIAA observed that EIA / EMP Reports generally did not meet the compliance of the TOR's as prescribed particularly w.r.t. S. No 4, 5, 8, 14-26, 28, 29, 31-34, 36-38, 39.

Environmental Quality Data should be rechecked / redone providing the methodology & instruments used, observations, results of analysis and the detection limits etc.

Modelling input & output data is also required providing how the predicting levels arrived.

Action Plans with Design parameters to control various environmental parameters are also required.

In view of the above, project proponents are required to re-submit the EIA / EMP Reports strictly adhering to the compliance of the TOR's as prescribed. Upon receipt, the same will be forwarded to SEAC for reappraisal."

SEIAA had given ample opportunity to the Project Proponent to explain the matter. However, Project Proponent has not availed the opportunity and did not appear.

SEIAA decided to send the matter back to SEAC to look into it in reference to the observations made by SEIAA and make fresh recommendations.

31. Hazardous Waste Management Facility of M/s Adityapur Auto Cluster.

SEIAA observed that a considerable delay has already happened in this case. SEAC may take necessary steps for the disposal of the case by its next meeting.

SEIAA has requested one of its members Dr. A. Bandyopadhyay to frame the template for the site inspection report. He would submit it to SEIAA by its next meeting.

32. Letter no. BR-01/14, Dated- 17/07/14 Jharkhand Pradesh Brick Manufacturers Association.

SEIAA decides to request the PCCF-cum-Nodal Officer, FCA to take up the matter with all the DFOs regarding issuance of distance certificate to Brick Manufactures. If DFO office does not issue the certificate in 30 days time from the date of application made to his office, the certificate would be deemed to have been issued. MS, SEIAA would decide the mechanism for the whole process. A letter would be written to the Jharkhand Pradesh Brick Manufacturers Association that the Project Proponent (Bricks Projects) would submit the application in duplicate to the DFO office concerned for the issuance of distance certificate, and would get the receipt of the DFO office under its seal on one copy of the application with the date of receipt clearly mentioned. The Project Proponent would submit the receipt in original with the project proposal to SEIAA.


35. Recruitment of One Computer Operator cum Typist.


