a) Municipal Solid Waste Management Project of M/s Jamshedpur Waste Processing Company Ltd.

SEIAA considered the request of Director, Municipal Administration, Ranchi Urban Development Department, Ranchi vide Letter No.-2/न०वि०/ठो०अप०प्र०(JSR)-02/12 dated-16.01.14 and agrees to the construction of boundary wall on the Govt. Land for its protection against the encroachment at its own risk. SEIAA advises The Project Proponent to expedite clearance/permission in this regard for AAI.

As permission has already been granted for seasonal environmental monitoring as an exceptional case, it is advised further that EIA/EMP process should be completed timely for consideration of appraisal/EC.

b) M/s Nitesh Sarda –regarding EC.

The application of the petitioner was considered for extending the EC from 5 yrs to 10 years. EC is extended upto 10 years subject to the condition of submission of Mining Plan approved by the authorised agency of the Jharkhand State Govt. as required by GOI/MoEF Office Memorandum No.-J-13012/12/2013-IA-II (I) dated 24-12-2013.
