The decisions taken in the 29th SEIAA meeting are as follows -


1. Minutes of the meeting of SEIAA, Jharkhand held on 30th December, 2014 were confirmed.
2. SEIAA decides that undertaking by project proponent related to Environmental Clearance must be mentioned in Environmental Clearance letter's condition.
3. The proposal considered in today's meeting to agree upon to issue Environmental Clearance provided the project under consideration has:-
 - a) Obtained all legal rights to operate at concerned place.
 - b) Complied with all existing concerned laws of the land and
 - c) Complied with the decisions of SEIAA on the issue of Environmental Clearance till date.
