**MINUTES OF THE MEETING OF THE SEIAA, MEGHALAYA, HELD ON 11th JULY
2016, AT 3 pm, IN THE OFFICE CHAMBER OF THE CHAIRMAN, SEIAA.**

Proceedings:

The meeting was chaired by the Shri T. Blah, IAS (Retd), Chairman, SEIAA. He welcomed Prof. B.K. Tiwari, Member SEIAA, and the Member Secretary. Then he invited the Member Secretary to present the Agenda points for discussion.

First, the Member Secretary informed about the action taken on the decisions made in the last SEIAA meeting dated 11/6/2016, the Minutes of which was already circulated. The meeting approved the actions taken and confirmed the Minutes.

Agenda 1 : Proposal for de-listing of projects :

account of non-response to the queries/directions from SEIAA/SEAC. The SEIAA also unanimously decided that the List shall be sent to the MoEF&CC, Govt. of India, Meghalaya Pollution Control Board, Divisional Forests Officer (Territorial), etc for their information and necessary action.
