The Member Secretary, SEIAA welcomed the Chairman and the Member of SEIAA. After general introductory remarks by the Chairman, SEIAA, the Committee took up items agenda-wise and reviewed the recommendations of State Expert Appraisal Committee (SEAC). After detailed deliberations & discussions on the recommendations of the SEAC, the SEIAA recorded their decisions on case to case basis as under.

The SEIAA noted that the proponent obtained EC for the project vide order dt.16.07.2011 from the SEIAA, AP (Combined State) and started construction of the project. But, now the proponent changed the project profile due to changing market demands and accordingly, decreased the no. of Residential Blocks from 6 Blocks to 5 Blocks and decreased no. of upper floors in the Commercial Block from 9 floors to 5 floors and requested the SEIAA to issue EC for the revised proposal.

The SEIAA discussed the recommendations of the SEAC in detail and noted that the project is to be considered for Amendment to EC, since, the proponent already started construction as per earlier EC. Hence, the SEIAA considered the project and approved the project for issue of Amendment to Environmental Clearance subject to submission of undertaking on following issues:
