

The proposal was placed in the 173 rd meeting of SEIAA and it was decided as follows: "EC granted with usual conditions stipulated for such irrigation (barrage) projects". The proponent has already submitted the Stage-I forest clearance vide letter no. 5-ORC292/2016-BHU, dated 18.11.2016.	As per decision of Authority dt.31.03.2017, EC was to be granted for the project. This decision was based on the premise that the proposal was categorized as B2 category project. However, this categorization needs clarification in the light of EIA Notification, 2006 of MoEF & CC, and subsequent amendments thereto, and therefore the above decision to grant EC is revoked for the time being.
