## Minutes of the 74<sup>th</sup> meeting of State level Environment Impact Assessment Authority, Jharkhand held on 18<sup>th</sup> June, 2019.

The 74th meeting of the State Level Environment Impact Assessment Authority (SEIAA) was convened on 18/06/2019 in the office of SEIAA, Ranchi. The meeting was chaired by Shri S.E.H. Kazmi, Chairman, SEIAA, Jharkhand. The attendance in the meeting was as follows:-

The decisions taken in the 74th SEIAA meeting are as follows:-

- SEIAA considered the recommendations made by SEAC in its 73<sup>rd</sup> meeting held on 12th, 13<sup>th</sup> and 14<sup>th</sup> June, 2019 for grant of Environmental Clearance to Building Construction Projects:
  - i. Proposed Civic Tower Building Construction Project of Jharkhand Urban Infrastructure Development Company Ltd (JUIDCO) at Vill.: Latma, Tehsil: Namkum, Ranchi.
  - ii. Proposed Convention Centre Building Construction Project of Jharkhand Urban Infrastructure Development Company Ltd (JUIDCO) at Vill. : Latma, Tehsil : Namkum, Ranchi.
    - It was decided to grant Environmental Clearance as recommended by SEAC to the above mentioned project proposals with the conditions recommended by SEAC subject to if remaining plot of above projects are found to be "Jungal Jhari" in future then project proponent will have to abide by the provisions of forest (conservation) Act, 1980 as per their undertaking dated 13.06.2019 signed by Deputy General Manager, JUIDCO.
  - iii. Ravindra Bhawan Building Construction Project of Jharkhand Urban Infrastructure Development Company Ltd (JUIDCO) at Kutchery Chowk, Opposite Jaipal Singh Stadium, Tehsil: Ratu, Dist.: Ranchi.
    - It was decided to grant Environmental Clearance to the above mentioned project proposal with the conditions recommended by SEAC.
  - iv. Construction of 500 bedded Government Hospital of M/s Jharkhand State Building Construction Corporation Ltd., Vill.: Dighi, Tehsil: Dumka, Dist.: Dumka.

It was decided to grant Environmental Clearance to the above mentioned project proposal with the conditions recommended by SEAC.

v. All India Institute of Medical Science (AIIMS) of M/s National Building Construction Corporation Ltd (NBCC) at Vill.: Utimpur, Sultanpur and Rampur, Thana: Deoghar, Dist.: Deoghar.

The Authority examined the recommendations made by SEAC where by SEAC has recommended to grant Environmental Clearance to the above mentioned project proposal subject to submission of revised DFO certificate stating remaining plot and khata no. of said project.
