Concrete measures have to be initiated towards compliance of the following stipulations of the initial EC, and information to that effect be submitted to SEIAA. Condition no. 3, 6, 7, 8, 9, 10, 13, 14, 16, 18, 21, 22, 23. PP may submit clear undertaking to this effect.

3. Letter no. 4546 dated 28.06.2017 from Tahasildar, Dhenkanal, has applied for modification of E.C of Gengutia Barada Sand Quarry (Long term lease 2016-17 to 2020-21).

**Decision of SEIAA:** The rationale of imposing quantitative restriction on extraction of sand is to ensure sustainability of mining over the entire lease period. If the PP insists on exploiting the entire estimated mineable reserve in the 1<sup>st</sup> year of operation, this might create a condition of non availability of sand for mining at the leased area in the subsequent years. The Collector of the district may take a decision on regulating the quantity to be extracted each year based on proper inspection of available stock of sand at the lease area at the beginning of each lease year.
