

## Minutes of the 57<sup>th</sup> Meeting of State level Environment Impact Assessment Authority, Jharkhand, held on 02 June 2018.

The 57<sup>th</sup> meeting of the State Level Environment Impact Assessment Authority (SEIAA) was convened on 02.06.2018 at the office of SEIAA, Ranchi. The meeting was chaired by Shri S.E.H. Kazmi, Chairman, SEIAA, Jharkhand. The attendance in the meeting was as follows:-

The decisions taken in the 57<sup>th</sup> SEIAA meeting are as follows –

The Authority going through Minutes of the 57<sup>th</sup> Meeting of State level Expert Appraisal Committee (SEAC) Jharkhand held on 31.05.2018 and 01.06.2018 and observed that SAEC Jharkhand has itself decided to exempt the public hearing of **M/S Medicare Environment Management Pvt. Ltd.**

The Ministry of Environment forest and Climate Change govt. of India has laid down the provision for exemption of public hearing vide S.O-695 (E) dated 14<sup>th</sup> SEP 2006.

Where Public ~~Constitution~~ is not necessary and the recommendation of the Expert Appraisal committee or State level Expert Appraisal Committee (SEAC) shall be placed before the Competent Authority for a final decision within next fifteen days:

Authority feels that SEAC Jharkhand has violating the norms of MoEF &CC and decided to exempt the public hearing to the above mentioned project proposal. Hence Authority decided unanimously to incept the decision of SEAC and be requested to avoid such incident in future. *SEAC should have recommended the exemption to SEIAA as per rule.*

### I. SEIAA considered the recommendations made by SEAC in its 57<sup>th</sup> meeting held on 31.05.2018 & 01.06.2018.

- a. Madalo Sand Mine Project on Ajay River of M/s Rajmahal Traders [Shri Ram Kumar Singh (Partner)] at Village- Madalo, P.O - Madalo, P.S - Nala, Dist. - Jamtara (23.48 Ha).

**It was decided to grant of Environmental Clearance to the above mentioned project proposal with the conditions recommended by SEAC.**

- b. Futberiya Sand Mine Project on Ajay River of M/s Sparkal World Pvt Ltd at Village- Futberiya, P.O. & P.S.- Nala, Dist.- Jamtara, (18.83 Ha).

**It was decided to grant Environmental Clearance to the above mentioned project proposal. With the conditions recommended by SEAC.**

- c. Kusbediya Sand Mine Project on Ajay River of M/s Dhanbad Wine [Sri Shankar Singh (Partner)] at Village- Kusbediya, P.O. & P.S.- Mihijam, Dist.- Jamtara(22.27 Ha).

**It was decided to grant of Environmental Clearance to the above mentioned project proposal with the conditions recommended by SEAC.**

- d. Gopalpur Sand Mine Project on Ajay River of M/s Swastik Traders [Sri Sudip Kumar Dey (Partner)] at Village- Gopalpur, P.O. & P.S.- Jamtara, Dist.- Jamtara, (24.25 Ha).

**It was decided to grant of Environmental Clearance to the above mentioned project proposal with the conditions recommended by SEAC.**

- e. Kuderu, Okra, Simla and Dorma Sand Deposit of M/s JSMDK at Vill.- Kuderu, Okra, Simla and Dorma, Tehsil- Torpa, Dist. Khunti (5.04 Ha).

**The authority examined the recommendation made by SEAC. Decided unanimously to referred the matter to SEAC with request to do not recommend the case till necessary amendments may not be included in the DSR of the district.**

- f. Bargunia Stone Mines of Sri Shailesh Kumar at Vill.-Bargunia, P.S. Madhupur, Dist. Deoghar (10.62 Ha).

**It was decided to grant of Environmental Clearance to the above mentioned project proposal with the conditions recommended by SEAC.**

- g. LPG Bottling Plant of M/s Hindustan Petroleum Corporation Limited at Adityapur Industrial Area, Large Sector, Vill- Gamharia, P.O- Gamharia, Saraikela-Kharsawan.

**The authority examined the recommendation made by SEAC. Decided unanimously to grant of Environmental Clearance shall be valid subject to clearance of proposal no-FP/JH/IND/33374/2018 under section 2 of the forest (conservation) Act, 1980 for division of fresh forest area.**

- h. Ekta Graphite Deposit of Sri Shishir Kumar Poddar at Vill. - Ekta, P.S.- Leslignaj, Dist.- Palamau (12.91 Ha).

**The authority examined the recommendation made by SEAC. Decided unanimously to grant of ToR with the condition to submit clearance of proposal no-FP/JH/MIN/29281/2017 under section 2 of the forest (conservation) Act, 1980 for division of fresh forest area and clearance from National Board of Wild Life (NBWL) prior to Environmental Clearance.**

- i. LPG Bottling Plant of M/s Hindustan Petroleum Corporation Ltd at Vill.-Konra, Barhi, Hazaribagh.

**The authority examined the recommendation made by SEAC. Decided unanimously to referred the matter to SEAC and asked to seek the clear clarification from PP regarding Status/ Class of land (whether proposed area is recorded as jangal jhari or not) then recommend it for final decision.**
