Project proponent with their consultant remained present before the committee and represented above proposal. He informed that mining operation is semi mechanized. The mining activity will result in pits which will be replenished in the subsequent rainy seasons. There will be no overburden generated during working. Cobbles present in the lease area will be sorted and will be put in the river bed. There is no applicability of CRZ Notification 2011.There is no bridge piers / water intake wells / irrigation structures within 500 m distance from boundary of above lease area. He explained that sand excavation will be done up to maximum 3 m depth. Mining will not intersect water table. Water sprinkling will be done during loading of material. Consumption of water is proposed to be 0.50 KLPD for domestic purpose, 2 KLPD for plantation and 2 KLPD for sprinkling purpose. Water will be procured from the nearby villages. All the transportation vehicles will be the budget for five years for EMP and Rs.11.00 lacs will be recurring cost per annum. PP informed that setback distance of 10 meter will be maintained from the river bank to prevent bank erosion.

It is noted that PP has submitted copies of approved mining plan, prefeasibility report including mitigation measures to curb pollution and details regarding non applicability of cluster formation for homogeneous minerals validated by the Geologist.

During appraisal referring to the approved mine plan, chapter 3, details of adjoining village are mentioned where in it is stated that Sinor village is located at 540 meter and Sisodara village is located at 550 meter wherein in application vide Form 1, under the chapter of environmental sensitivity, Sinor and Sisodara villages are mentioned s 1.43 km and 0.84 km away from the lease respectively. PP does not have submitted LOI from the concerned department mentioning lease in v\favor of applicant.

Project proponent with their consultant remained present before the committee and represented above proposal. He informed that mining operation is semi mechanized. The mining activity will result in pits which will be replenished in the subsequent rainy seasons. There will be no overburden generated during working. Cobbles present in the lease area will be sorted and will be put in the river bed. There is no applicability of CRZ Notification 2011. There is no bridge piers / water intake wells / irrigation structures within 500 m distance from boundary of above lease area. He explained that sand excavation will be done up to maximum 3 m depth. Mining will not intersect water table. Water sprinkling will be done during loading of material. Consumption of water is proposed to be 3 KLPD. Water

PP informed that setback distance of 10 meter will be maintained from the river bank to prevent bank erosion.

It is noted that PP has submitted copies of approved mining plan, prefeasibility report including mitigation measures to curb pollution and details regarding non applicability of cluster formation for homogeneous minerals validated by the Geologist.

It is noted that approved mine plan and project details validated by the geologist are not submitted by the PP mentioning that lease area is in dry river bed with no in-stream mining and applicability of cluster situation.

After deliberation, it is noted to ask PP to submit following details within 15 days so as to process EC application expeditiously.

Another letter from Shri Natubha Jadeja, At :Lifra, Ta: Mundra, Dist: Kutch is received by SEAC on 24/05/2018 wherein it is mentioned that PP has willfully hide the facts of existence of check dams under chapter of water body in the vicinity by not mentioning the same in Form 1.

For the aforementioned facts, notices for willful hide of the facts are issued regarding existence of water bodies in vicinity of the quarry leases were issued under clause 8(vi) of the provision of Environmental Impact Assessment (EIA) Notification, 2006 requesting project proponent to remain present before the SEAC on 11/07/2018 to clarify their stand as part of giving a natural justice with an opportunity of being heard as to why SEAC should not recommend for cancellation of environmental clearance for willful hide of the facts as per the clause 8(vi) of EIA Notification, 2006.

All the aforementioned Project proponent attended the SEAC meeting. They informed SEAC that letter from Kachchh irrigation Division, Bhuj dated 06/09/2017 is issued to SEAC which entails the said quarry lease is located at 140 meter away and other two leases are located in nearby. Further it is mentioned that a lake is located 150 meter away from the third lease. The said check dams are constructed under the scheme of 80:20 and in opinion of Kachchh irrigation Division, Bhuj the said leases are not causing harm to the check-dams.

After deliberation, committee asked PP to submit the current status of check dams and lake along with date of construction of these check dams located in upstream and downstream of the said quarry leases at the earliest.

Subsequently a letter of Shri Nanubhai H Patel and Bhikhubhai Aahir, At : Chasa,Ta: Chikhli, Dist: Navsari dated 11/04/2018 received by SEAC requesting to review environmental clearance accorded to the aforementioned quarry lease. In letter it is mentioned that Krishna Metal quarry

is located within 200 meter periphery of human habitation. A perennial river is also located adjacent to the quarry lease. Quarry lease is located near three check dams. A canal is also passing at a distance of about 150 meter from the said lease. State highway is located at 300 meter from the quarry lease. Looking to the aforementioned facts, it is informed that quarry lease is causing threats to the surrounding environmental entities.

Vide letter of Shri Nanubhai H Patel and Bhikhubhai Aahir, Regional officer, GPCB, Navsari requested to submit detailed report for the aforementioned facts. RO,GPCB, Navsari inspected the said quarry lease on 25/05/2018 and visit report mentions that Krishna Metal located at Survey No. 1742/ Paiki, Vill-Chasa, Dist-Navsari is an active black trap mine.

It is stated that from mine lease area, Tankal-Dehgam road (SH) is @ 100 m N-W, a minor river named as Fukri passing adjacent @ 20m in East, three minor check dams observed constructed over this water body with approximate distances (a). 150 m in North,(b). 80m in N-E & (c). 70m in South, seepage of water observed in this operative mines. High voltage line is @ 170m in West. The village falia having few houses is located at 100 meter in West of mines. Till date quarry lease does not have provided approved mining plan however mining work is in progress during visit.

For the aforementioned facts, notice is issued for willful hide of the facts regarding existence of water bodies in vicinity of the quarry lease was issued under clause 8(vi) of the provision of Environmental Impact Assessment (EIA) Notification, 2006 requesting project proponent to remain present before the SEAC on 11/07/2018 to clarify their stand as part of giving a natural justice with an opportunity of being heard as to why SEAC should not recommend for cancellation of environmental clearance for willful hide of the facts as per the clause 8(vi) of EIA Notification, 2006.

Project proponent could not attend the meeting and has requested committee to grant time as he has met with an accident. A medical certificate is submitted by the PP in this regard. Committee took notice of the medical certificate and decided to invite the PP after 45 days to clarify the stand as part of giving a natural justice with an opportunity of being heard under clause 8(vi) of the provision of Environmental Impact Assessment (EIA) Notification, 2006 Committee decided to invite the PP after 45 days and then after decision of the case will not defer further.
