The Proponent of "M/s. TALCO-Dindigul Tanners Enviro Control Systems Pvt. Ltd.," has submitted an application in updated Form I, IA & Conceptual Plan to SEIAA-TN for obtaining Extension of Environment Clearance already issued on 30.10.2009 by SEIAA-TN for providing secured landfill facility at S.F.No.628/1A, 1B, 1C, 2, 642/1A, 1B, 1C, 1D, 2A, and 2B, Pallapatti Village, Dindigul Taluk, Dindigul District, Tamilnadu. This project falls under category "B1"- 7(d) Common hazardous waste treatment, storage and disposal facilities (TSDFs).

The project was placed in the 91st SEAC meeting for considering extension of EC based on the MoEF&CC OM F.no.22-27/2015-IA-III dated: 12.04.2016, vide sub clause (iii) which clarifies that "The Environmental Clearance of the projects which have completed five (5) years on the date of publication of Notification i.e. 29.04.2015 and application of seeking extension of Validity has not been submitted within the validity period by the Project Proponent, their extension of Validity will be decided on case to case basis".

The EC was issued on 30.10.2009 with a valid period of 5 years which ends on 29.10.2014. The proponent states that due to the non-availability of funds, he could not

commence the project till now. It is informed during the presentation that funds have been made available now for the project and the Proponent made a request to extend the validity of the EC. In between the Proponent has not made any request in this direction. Such cases are to be dealt with by the SEAC case to case as notified in the Notification of MoEF & CC cited above and accordingly the SEAC considered the request for the extension of the EC.

Based on the presentation made by the proponent and the documents furnished, the Committee decided to recommend the proposal for the grant of EC extension to SEIAA for a period of 3 years from the date of issue.
