ToR along with Public Hearing was issued vide Lr.No. SEIAA-TN/F.No. 4389/SEAC-LXIX/ToR – 233/2015 dated: 19.11.2015. This project proposal was to be considered as a cluster project with namely Tmt. Varalakshmi for mining of Grey Granite Mine over an extent of 1.08.5 Ha at S.F. No. 341/4 & 335/4B, Sulamalai Village, Bargur Taluk, Krishnagiri District. These two project sites are separated by a distance of 265m which is less than 500m. Hence, these two projects were to be considered as cluster and the SEAC permitted the proponents to prepare a common EIA report along with respective EMP. Accordingly, the proponents submitted the combined EIA Report along with EMP on 15.02.2018.

The subject was placed before the 105th SEAC Meeting held on 22.03.2018. The proponent made a presentation about the salient features of the project. The SEAC observed from the proposal and from the presentation that approved mining plan has been applied for and the proponent is yet to get the approved mining plan. In the absence of the approved mining plan, the SEAC decided to defer the appraisal process and directed the proponent to

obtain the approved mining plan and submit the same for consideration for appraisal.

The above details was communicated to the Project Proponent vide SEIAA letter dated 26.03.2018. The Project Proponent has furnished the approved mining plan on 14.04.2018.

The subject was placed before the 109th SEAC Meeting held on 24.04.2018. The Committee decided to recommend to SEIAA for grant of EC subject to the following condition in addition to normal conditions:

- It is subjected to the conditions of the MMDR Rules, 1957, Mines act, 1952 & Tamil Nadu Minor Mineral Concession rule as applicable besides usual general terms and conditions.
- 2. The proponent shall furnish the District survey report (DSR) as per the MoEF & CC notification dated:15.01.2016, giving all data and particulars relevant to the project.
