The proposal was placed in the 127th SEAC Meeting held on 15.03.2019. The project proponent gave detailed presentation. The salient features of the project and the environmental impact assessment as presented by the proponent are as follows:

1. Government order/ Lease details:

The Quarry lease was applied in the name of Tvl.Patel Infrastructure Limited, Gujarat, Precise Area Communication letter was issued by the District Collector, Ariyalur vide R.c.No. 326/G&M/2018 dated 10.12.2018 for a period of 3 months. It is a Fresh lease Earth / Savudu / Gravel quarry over an extent of 4.50.0 Ha Ponneri in S. F. No. 105 (P) in Amanakkanthondi Village, Udayarpalayam Taluk and Ariyalur District.

2. Mining Plan/Scheme of Mining approval details:

Mining plan was prepared for the period of 3 months. The Mining Plan was got approval from the Deputy Director, Department of Geology and Mining, Ariyalur vide R.c.No. 326/G&M/2018 dated 31.01.2019.

- 3. As per the Department of Geology and Mining, Ariyalur District, Mining plan approved for the 3 months, the production schedule for 3 months states that the total Quantity of Gravel should not exceed 45,000m³ upto a depth of 1m below the ground level.
- 4. There is no wastage encountered during the quarrying operation, the entire excavation will be used for filling and levelling of low lying areas road project and other infrastructure development work in and around the District

- 2. The project/activity is covered under Category "B2" of Item 1(a) "Mining of Minor Mineral Projects" of the Schedule to the EIA Notification, 2006.
