The project proposal was placed in the 110th meeting of the SEAC held on 04.05.2018. Based on the presentation made by the proponent and the documents furnished, the SEAC decided to recommend the following Terms of Reference (ToR) for preparation of EIA to SEIAA in addition to the Standard ToR.

- 1. The project proponent shall submit the compliance report from Regional office, MoEF & CC, Chennai for the Environmental Clearance issued earlier SEIAA vide Lr.No. SEIAA/TN/F.6397/EC/8(a)/535/2017 dated: 13.09.2017 while submitting EIA.
- Certificate stating that the proposed site has (all survey numbers)
 not encroached any water body (rivers, canals, lakes, ponds, tank,
 etc) from its original boundary shall be obtained from the PWD.
- 3. The project proponent has to allocate 15% for Green belt area considering all the three phases (phase I, phase II & phase III). The Green belt should be raised all along the boundary and in between the Blocks by planting indigenous ever green species with good foliage. Detailed green belt plan with the dimensions should be furnished.
- 4. The treated sewage of 904 KLD is proposed to be disposed through the CMWSSB network. The proponent may find out alternate suitable and practical method to reduce the treated sewage discharging into CMWSSB network.
- 5. Two canals are running through the project site. Hence the proponent is directed to furnish the NOC obtained from PWD, since the PWD owned canals passing through the proposed site.
- 6. Regarding Corporate Environment Responsibility (CER) activities, the proponent should give details of the CER activities which will
