Proposed construction of Warehouse "Indospace Industrial Park" by M/s. Initially, the Proponent, M/s. IHINA Industrial & Logistics Park Private Limited applied for Environment Clearance to SEIAA-TN on 27.06.2018 for the construction of Warehouse "Indospace Industrial Park" at Survey Nos. 13/1B1A2, 13/1B1B2, 13/1B2A2, 13/1B2B2, 32/1B, 32/3B, 32/4B, 33/1B, 33/2B, 33/3, 33/4, 34/1, 34/2, 34/3, 34/4, 34/5, 35/1, 35/2, 36/1A, 36/1B, 36/2, 36/3, 36/4A, 36/4B, 37/1B, 37/2A2, 37/5B2, 37/5C, 37/5D, 37/6B, 37/7B, 38/1, 38/2, 38/3, 38/4A, 38/4B, 39/2A1, 39/3, 39/4A, 39/4B, 39/5A, 39/5B. 40/1A, 40/1B, 40/1D, 40/2, 41, 43/1, 43/2, 43/3A, 43/4 of Venpakkam Village, Walajabad Taluk, Kancheepuram District. Totally there were 62 Survey Nos. representing the land area proposed for the construction.

The proposal (F.No.6602) was placed in the 113th SEAC Meeting held on 05.06.2018. The proponent made a presentation about the project proposal and SEAC members interacted with the proponent about the project proposal. The SEAC noted that the NOCs have been obtained from the District Collector, Kanchipuram in respect of 50 Survey Nos out of 62 and NOC for remaining 12 Survey Nos. have not been obtained. Hence, SEAC decided to recommend the proposal to SEIAA-TN for issue of EC subject to several conditions to be met, one condition being that the NOCs for the

remaining 12 Survey Nos. should be obtained and submitted by the proponent. The SEIAA-TN directed the proponent to a proposal to include only the land area for which NOCs have been issued and accordingly the proponent has submitted a new proposal on 27.06.2018 (the current proposal with File No. 6631) by including the Survey Nos. for which NoCs have been issued by the District Collector.

The current proposal dated: 27.06.2018 was placed in the 115th SEAC Meeting held on 27.06.2018. The proponent made a presentation about the project proposal. The salient features of the proposal are as follows:

- 1. The project involves construction of warehouse in a land area of 68,879 sq.m and built up area of 25,986.15 sq.m.
- 2. The warehouse is intended for storing automobile and electronic components. Even though the project name is Indospace Industrial Park, there will not be any industrial activity like raw material handling, production process, product management, emission and hazardous waste generation. Other than the building, there will not be any mechanical and electrical equipment that will be housed in the premises. Because of this fact, the SEAC decided in principle to appraise the project proposal under category 8 (a) building and construction project.
- 3. - 9. District collector, Kanchipuram permission/NoC & DTCP

- approvals should all be in the name M/s. IHINA Industrial & Logistics Park Private Limited and the permission should cover the relevant survey Nos. and proposed land area.
- 10. The proponent has obtained the approval from DTCP letter dated 20.11.2017 for the area of 2147.60 Sq.m. But the built up area of the proposed ware house is 25986.15 Sq.m.
- 11. The location of the warehouse is at Venpakkam Village which is about 1km from the proposed site.
- 12. Green belt area provided is 13850 Sq.m (20%) against requirement of 33%. The proponent should enhance the green belt area in near future to satisfy the norms. The present area allocation is satisfactory in the point of view of building and construction project.
- 13. The proponent has proposed 10 KLD STP for the treatment and disposal of sewage.

The SEAC decided to recommend the proposal of M/s. - the proposed project and the approvals should all be in the name M/s. IHINA Industrial & Logistics Park Private Limited and the permission should cover the relevant survey Nos. and proposed land area. This EC will be valid only after obtaining the DTCP approvals as said above.
- iii) The proponent shall provide organic waste converter for the treatment and disposal of solid waste before obtaining CTO from TNPCB.
- The project proponent shall furnish the copy of the certificate stating that the proposed site had not encroached any water body (rivers, canals, lakes, ponds, tanks, etc) from its original boundary as obtained from the competent authority.
- v) The proponent shall utilise the warehouse only for storing automobile and electronic components.
- vi) The proponent shall ensure that no hazardous chemical/waste shall be stored within the warehouse.
- vii) The proponent shall ensure that no industrial activity shall be carried out within the premises.
- viii) The proponent should obtain the necessary clearances from PWD, keeping in mind the close proximity of the project site to the water body (Venpakkam Lake).
- ix) The proponent shall ensure that no treated/untreated sewage shall be discharged in to the nearby lake either directly or indirectly.
- x) The project activity should not affect the habitation nearby in the form of dust and noise pollution.
- xi) The proponent shall implement all environmental protections measures committed in the proposal.
- xii) There should not be any adverse Impact of movement of
