Additional Conditions


1. Industry shall operate and maintain the air pollution control system /particulate matter emission control system regularly to ensure the emission within 50 mg/Nm³ all the time. Effective steps shall be taken to maintain the ambient air quality within the prescribed limits all the time. All the pollution control system shall be kept in good running condition all the time and failure (if any) shall be rectified immediately without delay otherwise some alternative arrangement shall be made. In event of failure of any pollution control system adopted by industry, the

respective production unit shall not be restarted until the control measures are rectified to achieve desired efficiency.

2. Regular monitoring for the measurement of air pollutants level in ambient and emission of air pollutants from stack shall be carried out. Industry shall submit stack & ambient air quality monitoring report to the Board regularly.
3. Industry shall use fly ash brick, fly ash blocks or fly ash based products in their construction/repairing activities.
4. All internal roads shall be made pucca. Good house keeping practices shall be adopted by the industry.
5. Wide green belt of broad leaf local species shall be developed along the plant premises. As far as possible maximum area of open spaces shall be utilized for plantation purposes.
6. Industry shall submit Environment Statement to this Board as per provision of Environment (Protection) amendment Rule, 1993 for the previous year ending 31st March on or before 30th September every year.



Industry shall not discharge effluent out side the factory premises in any circumstances; hence zero discharge conditions shall be maintained all the time.
2. Industry shall provide adequate arrangement for proper, safe and scientific storage, handling and disposal etc. of all solid wastes generated.
3. Industry shall use fly ash brick, fly ash blocks or fly ash based products in their construction/repairing activities.

4. All internal roads shall be made pucca. Good house keeping practices shall be adopted by the industry.
5. Industry shall obtain letter of authorization under Hazardous Materials (Management, Handling and Transboundary Movement) Rules, 2008 (as amended up to date) from the Board, if any waste comes under the purview of Hazardous Materials (Management, Handling and Transboundary Movement) Rules, 2008 (as amended up to date).
6. Industry shall submit water cess return to the Board regularly as per the Water (Prevention and Control of Pollution) Cess Act, 1977 (as amended).
7. Wide green belt of broad leaf local species shall be developed along the plant premises. As far as possible maximum area of open spaces shall be utilized for plantation purposes.
