2. Proposal of EC for mining of Boulder, Gravel, Sand- Gravel, Sand from "P.P Land of Khanibhur Village" under Chirang Division proposed by Sri Philip Narzary SEIAA.1496/2020, (SIA/AS/MIN/180742/2020).

#### SEAC Resolution 28/3:

The project proposal asking EC for mining of boulder, gravel, sand-gravel and sand from the "P P Land of Khanibhur Village "under Chirang Forest Division proposed by Sri Philip Narzary is placed before the SEAC for appraisal and discussion. Requisite documents submitted by the proponent including reply of EDS are examined. Detailed discussion is held. It is revealed that the validity of the approved mining plan will expire on 4th April, 2025. Considering all the aspects and approved mining plan, the committee recommended for mining of 5000 cu.m gravel; 5000 cu, sand-gravel; 5000 cu.m sand and 15000 cu.m river boulder from the proposed mining site till expiry of the validity of the approved mining plan i.e. 4th April 2025. The proponent is permitted to extract 1250 cu. gravel; 1250 cu.m sand-gravel; 1250 cu.m sand and 3750 cu.m river boulder from the approved mining site per year. #### SEAC Resolution 28/8:

The proposal of EC for mining of sand from "Jhanji River Sand MPA 'E'; Sandghat-A" under Sivasagar Forest Division proposed by Sri Bijoy Buragohain is placed before the SEAC for appraisal and review. Scrutinized the documents including the reply furnished against the EDS raised from this end. Discussion held in details. Considering the technical problem and recommendation of the concerned DFO, the committee recommended the proposal for mining of sand delineating 0.6 hect area along the meandering of the outer river course between the GPS coordinates E-94°30'10.73", N-26°49'35.72" / E-94°30'11.39" N-26°49'35.29" and E-94°30'16.98", N-26°49'31.32"/E-94°30'16.17" N-26°49'31.41" that are to be maintained as non-mining zone within the proposed mining site. The committee recommended to extract 1600 cu.m sand from the remaining 1.33hect. minable area within two years. It is approved to extract 800 cu.m sand per year from the approved minable area strictly following all the other terms and condition laid down in the approved mining plan.

The Divisional Forest Officer, Sivasagar Division is requested to ensure that the approved mining site (1.33 Hect.) be marked on the ground fixing pillars before allowing actual mining operation leaving the meandering site as discussed above. He will also ensure due surveillance to avoid occurrence of irregularities during the pendency of the mining period.
