The Authority after detailed discussion and deliberation decided the following:

- 1. S. No. 1: The Authority accepted the recommendations of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the conditions that trees of height 6ft or more should be planted and maintained to mitigate dust emission and all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 2. S. No. 2, 4, 5, 6, 7, 8: The Authority accepted the recommendations and decided to grant ToR to these proposals with the additional conditions of SEAC.
- S. No. 3: The Authority accepted the recommendations & additional conditions of SEAC and decided to grant ToR to this proposal under violation.
- 4. S. No. 9: The Authority accepted the recommendations of SEAC and decided to grant EC to this proposal with the condition that the LoI condition regarding kachha rasta shall be adhered to.
- S. No. 10, 11, 12, 14, 15, 17, 18, 20, 21, 22, 24, 29, 30, 31, 33, 34, 36, 37, 39: The
   Authority accepted the recommendations of SEAC and decided to grant EC to
   these proposals.
- 6. S. No. 13, 19, 23, 28: The DSR submitted for these proposals is not of the same mineral as per the proposal. Hence, The Authority decided to defer these proposals for additional information.

- 7. S. No. 25, 26: The Authority accepted the recommendations of SEAC and decided to grant EC to this proposal with the condition that the conditions mentioned in WRD Certificate shall be adhered to.
- 8. S. No. 27: In this Proposal, DSR submitted is of marble instead of Quartz & Feldspar and a Tar Road is at 10 m from the lease boundary in North direction and adjacent to the lease boundary in East direction. No safety plan for the same has been proposed. Hence, the Authority decided to defer this proposal and directed to obtain information on category of the above-mentioned road from PWD.
- No. 32: In this proposal, uploaded KML is of different project. Coordinates and shape proposed do not match. Hence, the Authority decided to defer this proposal for reconfirmation of coordinates.
- 10. S. No. 35: The Authority accepted the recommendations of SEAC and decided to grant EC to this proposal with the condition that the condition mentioned in LoI regarding High Tension line and Affidavit submitted for the same shall be adhered to before mining is commenced.
- 11.S. No. 38: In this proposal, as per the DCF Certificate Mukundra Hills Tiger Reserve is at a distance of 8.45 km and Chambal Ghariyal Sanctuary is at a distance of 8.45 km. Hence, the Authority decided to Close and Delist this proposal till such time the NBWL Clearance is obtained.
- 12. S. No. 40: The proposal mentions River Jojri at a distance of 45m from the lease area. Hence, the Authority decided to defer this proposal for WRD Certificate for the same.
- 13. S. No. 41: SEAC has recommended this proposal for grant of EC along with bank guarantee of ₹ 41.7 lacs for remediation plan, natural resource augmentation plan & community augmentation plan and also a penalty of ₹ 9.625 lacs.

Hence the Authority decided to accept the recommendations of SEAC and grant EC to this proposal subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of ₹ 9.625 lacs by online/ Demand Draft mode and also submit the Bank Guarantee of ₹ 41.7 lacs towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.

- 14.S. No. 42: In this proposal, it has come to the notice that production has been exceeded from the granted capacity as mentioned in EC. Hence, the Authority decided to grant Transfer of EC to this proposal with a direction to project proponent to apply for ToR under violation within next 30 days failing which action shall be initiated against the project proponent.
- 15.S. No. 43: The Authority accepted the recommendations of SEAC and decided to grant Transfer of EC to this proposal.

PP has submitted the CA certified incurred cost & turnover but has not submitted the recent certified compliance report of EC. Hence, the Authority decided to defer the case for additional information.
- 20. S. No. 49: Proposal was deferred in 5.57th meeting of the Authority stating "In this proposal there is discrepancy in coordinates of the lease. Hence, reconfirmation of coordinates is required". Now, PP has submitted the re-verified coordinates as well as KML. Hence, the Authority decided to grant EC to this proposal.
