It is requested that the Project Proponent or his/her authorized representative (The authorisation letter to be attested with Aadhar card of the project proponent to the authorised competent person) should participate in the presentation meeting of SEAC, who can respond or make commitment to the queries/suggestions of the Committee. The name of representatives may be communicated in advance.

For the purpose, the documents such as Form-1, Environment Impact Assessment Report, public hearing report, Action Plan on the issues raised during PH, queries (EDS and ADS) subsequently raised, if any, and your para-wise comments thereto etc., are required to be forwarded to the Chairman/Members of the SEAC

Also to submit the details of the court matters/Orders of the Court pertaining to the project, if any

It may be ensured that the Members receive the aforesaid requisite documents in soft copy/e-mail pertaining to the projects after publishing the agenda positively. Failing which the Committee will not consider the project.

The Project Proponents shall ensure that the reports / documents uploaded in PARIVESH, circulated to the SEAC members and hard copy submitted to the Office are the same. In case of discrepancy, the project will not be considered.

- The Consultant shall include an undertaking in the EIA report that the prescribed TOR have been complied with and that the data submitted is factually correct and also an undertaking shall be submitted owning the contents (information and data) in the EIA/EMP report.
- The industrial projects shall present carbon foot print, net zero/de-carbonisation mechanism, carbon sequestration study and Zero Liquid Discharge (ZLD) etc., with respect to proposed project and their mitigation measures also needs to be included in the Presentation. In case the expansion industry project, required to submit the performance evaluation and checking the adequacy for the existing pollution control systems if additional pollution control measures are not proposed.
- The Infra projects shall present green building initiative with Architectural Design brief, Energy efficient different building materials with U & R values, Electric charging facility (Fast and regular charging details), ECBC/BEE norms compliance. Labour colony details and its management. The concerned Architect along with PHE expert should accompany with EIA coordinator during the meeting.
- Corporate Environmental Responsibility (CER) should be a part of EMP cost, the CER shall be specific activity, time bound and should support the environment in compliance to the office memorandum dated 1st May 2018 (F.No. 22-65/2017-IA-III) and subsequent OM dated 30th September 2020, 20th October 2020 and 25th February 2021.
- Project proponents are required to inform the Member Secretary SEAC if they are unable to attend the meeting and absent due to un avoidable circumstance, well in advance either through mail or a letter.
