The site is near to Tondiarpet Tollgate bus depot @25m, proposed Metro station at Tollgate is @30m & MTC bus services are available on three sides of the project in North Terminus Road, in Thiruvottiyur Highway and in Ennore Express Road. Hence, traffic survey using a suitable Model considering the above factor and furnish the predicted emission.
- 4. From the CMDA land use classification map it was noticed that the site falls under the industrial zone classification. Hence, the land conversation from industrial zone to commercial zone shall be obtained from the competent Authority.
- 5. The proponent shall furnish the detailed Storm water drainage plan and the Flood Management plan along with the contour map based on the 2015 Flood.
- 6. The proponent shall carry out the Traffic survey and traffic modeling in at least two vulnerable sites and submit the report.
- 7. From the photograph produced from the proponent during presentation it was noticed debris at the site. Hence, the details related to the demolished building in the site and the quantum of the demolished material and how it's managed shall be elaborated.

The project comes up in an area which was originally classified as industrial use zone. Industries are seen nearby the proposed project site. Specifically, in the south-west corner of the project site, foundry industry exists. This is just adjacent to the proposed project site. Foundry has potential to cause air pollution which will pose health problems for the residents nearby. Keeping in mind the possible adverse impact of the industry operation on the residents of the proposed apartments, the G.O stipulated a condition of earmarking 15m wide land space and use that as green belt for pollution abatement. The proponent has not complied with this requirement. He has earmarked 15m wide landspace but that has been marked to serve the purposed of OSR which will be quite different from the purposed served by the green belt.

Since, proponent has not earmarked a 15m wide landspace for green belt as per G.O. the SEAC directed the proponent to submit a revised building plan approved by the Local Planning Authority clearly earmarking the area in the plan as per the G.O requirement.

The project proponent was informed the above facts vide SEIAA letter dated 26.03.2018 request to submit the details. The project proponent vide their letter dated 20.02.2020 submitted reply to SEIAA informing that

The proposed project comes up in an area which was originally classified as industrial use zone, therefore we had specifically got our land converted to residential use classification, but currently after merger of Vilankuruchi Village into Coimbatore Corporation, they have classified the complete road, where our proposed project land is located, now known as Vilankuruchi corporation – THANNEER PANDAL ROAD, as a **Residential Class 1 – Type 1 Zone** under the Coimbatore Corporation.

We also would like to draw your attention to a foundry which was earlier located adjacent to the South-West corner of the proposed project site, for which the committee was particularly concerned. We wish to inform you that this particular foundry has been removed around 18 months back by its existing owner and has now given way to an Office cum Godown of a Bangalore-based company.

With the above detail the proposal was placed in this 149<sup>th</sup> SEAC Meeting held on 14.03.2020.

The SEAC noted the following:

  - a. The Mining plan was prepared for the period of 60 days. The mining plan was got approval from the Assistant Director, Department of Geology and Mining, Kancheepuram District vide, Roc. No. 829/Q2/2018, Dated 26.06.2019.
- 3. As per the Department of Geology and Mining, Kancheepuram District. Mining Plan approved for the 60 days, the production schedule is 28350 m<sup>3</sup> of Savudu for 60 days.
- 4. The quarry operation is proposed up to a depth of 0.9m Below Ground level.
- 5. The Quarry operation is proposed to carry out with open cast semi mechanized mining using excavator and Tippers/Tractor combination.
- 6. Savudu shall be transported by Tippers of 5 Nos. (10 M. T Capacity).
