Reading of presentation slide will not be allowed and in such cases, the presentation to be deferred to next meeting.**

Further, you are requested to depute an authorized senior officer who can explain the project and also respond to the queries / suggestions of the Committee members. He should be authorized to offer commitments on behalf of the proponent. **Many a times, it is observed that, in case of minor mineral projects, only Environment consultant and project proponent are present during presentation and unable to respond the queries of the Committee members. Therefore, the concerned Tahasildar/representative of Tahasildar (not below the rank of Additional Tahasildar) along with Environment Consultant, RQP and project proponent shall be physically present, to respond to the queries / suggestions of the Committee members.**

A line in confirmation regarding participation of your representative in the meeting will be appreciated. It may be noted that only the EIA consultant who has already been accredited with Quality Council of India can only accompany the proponent in the meeting.

In this regard, you are requested to forward a copy of **Form-1, Form-1 A, pre-feasibility report and EIA/EMP report as per applicability along with soft copy of presentation to all the members of the State Level Expert Appraisal Committee and seac.odisha.2019@gmail.com through email before 5 days of the meeting positively without which the proposal will not be considered and will be deferred to next meeting. In addition to it, incase of Minor Mineral projects, Project proponent shall submit the real time video taken 2-3 days before, prior to the presentation meeting showing the current status of mining lease, availability of sand and transportation route (if any). Many a times, it is observed that, the executive summary of the project is submitted too casually, containing no detailed description of Project. Such cases will not be considered and will be deferred to next meeting.**
