# SEAC Resolution 23/2:

The proposal asking EC for mining of Brick earth from "M/S J.R.K Bricks MPA" under Kamrup West Division, Bamunigaon proposed by M/S JRK Bricks is placed before the SEAC for appraisal and detail discussion. Scrutinized the documents furnished along with the proposal. Necessary discussion is held. After due deliberation the committee recommended the proposal to approve EC for mining of 4000 cu.m. brick earth within 2(two) years within the limit of the proposed site falling in the following GPS coordinates.

The proponent be allowed to extract 50000 cu.m stone per year strictly following all other terms and condition laid down in the approved mining plan.

The DFO shall have also to mount regular and strict surveillance to avoid occurrences of irregularities during the mining period added with safe guard of the nearby water supply scheme.
