Recommendation of SEAC:-

Earlier, the proposal was rejected by SEAC and was decided that the proposal can be reconsidered if the proponent submits the revised proposal complying the observations of SEAC. The SEIAA conveyed the decision of SEAC to the proponent vide letter no. 8036/SEIAA dated 20.03.2020. The SEIAA vide this letter had further asked the PP to submit the additional information sought by SEAC for further consideration of the proposal. The following were the observations of SEAC for compliance for further reconsideration of the proposal for EC:

- (i) Greenbelt area is proposed to less than 20% (i.e. 10%).
- (ii) There is no proposal for installation of STP.
- (iii) Parking area proposed is inadequate (i.e. 10% instead of 20%)
- (iv) There is no provision of lift though proposal is for G+5 storied building.

In the meantime, the Vice-Chairman, BDA has requested to the Chairman, SEIAA vide letter no. 6538, dated 13.03.2020 that the evaluation of the building proposals for Environmental Clearance may be carried out in accordance with the prescribed provisions of the planning and building standard regulations. He has pointed out some ambiguities on the observations of the SEAC on the above project such as provisions of greenbelt, parking space, lift and STP etc. The SEIAA forwarded the letter of Vice-Chairman, BDA to SEAC for reconsideration/views on the request.

Views of SEAC on the Vice-Chairman, BDA Letter:

- The EIA Notification, 2006 & amendments thereafter under the provision of Environment (Protection) Act, 1986 regulates Building and Construction projects with prescribed standard statutory procedures for Environment Protection & Pollution Control. In case of a conflict between the State Law viz. BDA regulations on Building & Construction projects and the Central Environment Law, the later prevails.
- Therefore, the said proposal was rejected by SEAC after due and careful consideration of the provisions of Environment Law, Standards & Norms. Moreover, the similar proposals (EWS) of the BDA at Ghatikia, Kalinga Nagar, Bhubaneswar had been recommended for Environmental Clearance with the provisions of the norms for greenbelt, STP and parking provisions. The project proponent of the EWS had also applied for Environmental Clearance complying to the norms.
- While a liberal view may be taken in case of parking space and provisions of lift etc., it was difficult to overlook the necessity of prescribed Green Belt and STP. To illustrate a vital aspect of environment in Building projects & provision of STP, this may not be out of place to illustrate the following to appreciate the importance of STP:
 - ✓ Sewage shall be treated in the STP with tertiary treatment. The treated effluent from STP shall be recycled / re-used for flushing; land scape irrigation etc. to maintain Zero Liquid Discharge (ZLD) and no treated water shall be discharged into the Municipal drain.
 - ✓ Installation dual pipe plumbing for supplying fresh water for drinking, cooking, bathing etc., the other is provided for supply of recycled water after treatment in STP for flushing etc.
- The environmental objective is to maintain “Zero Liquid Discharge” and no wastage of treated / untreated waste water and conservation of resources like water. Therefore, EIA Notification prescribes statutory compliance of onsite sewage treatment of capacity of treating 100% waste water with installation of STP.

Decision of SEAC on the Proposal: The SEAC after detailed deliberation and in consideration of the views of the explanation given by the Vice-Chairman, BDA in the aforementioned letter in the larger interest of the community, have recommended to grant Environmental Clearance valid for 7 years with stipulated conditions in addition to the following specific conditions.

- (i) The operation of the JICA sewer line shall be synchronised with the operation of the proposed building project and in case of delay in the project of JICA, the operation of the proposed building project shall not be allowed. Regional Office of MoEF & CC, Bhubaneswar shall be intimated to this effect for monitoring and so also ORERA. Here, operations of the building project mean to allow to stay the inhabitants in this housing complex.
- (ii) Senior Citizens / physically challenged people shall be allowed houses in ground floor of the proposed building project in-absence of provisions of lift.
- (iii) The proponent shall explore the possibility to augment green belt and parking space as maximum as possible and as closer to achieve the environment norms.

Further, the SEIAA, Odisha may consider to issue Environmental Clearance after receipt of formal appeal from the proponent in online portal / system (The project proponent has not made any appeal to reconsider the proposal in light of the request of the Vice-Chairman, BDA to the SEIAA, Odisha rejection of EC letter issued vide letter no. 8215/SEIAA, dated 19.05.2020 and the online file is with the proponent) to reconsider the proposal in addition to the following documents:

- (i) An undertaking in form of legal affidavit from the controlling Authority of JICA in the Govt. that the sewer line of JICA will be able to take additional load of untreated waste water of the proposed project.
- (ii) An undertaking in form of legal affidavit from BDA / Housing and Urban Development Department that the operation of the JICA sewer line will synchronise with the operation of this proposed building project and in case of delay in the project of JICA, the operation of the proposed building project will not be allowed.

Again, the SEAC opined that this proposal was considered for Environmental Clearance as a special case, project specific and this should not be an example and shall not be quoted / treated as precedence for future projects.

The SEAC further recommended that the SEIAA, Odisha may consider to request the Vice Chairman, BDA / H&UD Deptt., Govt. of Odisha that they may bring, if they desire, necessary clearance from MoEF&CC, Govt. of India for relaxation of Central Environment Act on Building projects in line with BDA regulations for future EWS projects.

Decision of SEIAA: We may address a letter to BDA informing them of the standard conditions stipulated by MoEF for such projects, and also the undertaking proposed by SEAC in regard to disposal of waste water. EC will be contingent upon their agreeing to abide by these stipulations.

The Meeting ended with a vote of thanks to the Chairman.
