**Minutes of the 15<sup>th</sup> Meeting of SEIAA (Day-II) held on 28<sup>th</sup> October, 2023**

The meeting was chaired by Shri A.R. Sinha, Chairman, SEIAA Uttarakhand and was attended by the following:

- (i) Dr. Chandra Bhushan Prasad Member, SEIAA Uttarakhand.
- (ii) Shri S.P. Subudhi, Secretary, SEIAA Uttarakhand.

The meeting started with welcome note by the Chairman. The Member Secretary informed that total 11 proposals (B1 & B2) are under consideration for grant of EC and 3 proposal for ToR in this meeting. After detailed discussion and deliberation on each of the proposal as per agenda item, decision taken by the Authority is as under -

- 1) Environmental Clearance for Proposed Printing of Aluminium Foil & manufacturing of Poly Bags at E-8/2, 8/3 UPSIDC Industrial Area, Selaqui, Tehsil- Vikas Nagar, Dehradun by M/s Almed Printing Solutions Private Limited by Shri Kailash Chand Melana (Director). Online proposal No SIA/UK/IND1/447568/2023.

The Authority agreed with the recommendations of SEAC and decided to grant the Environment Clearance with the terms and conditions recommended by it.






The Authority agreed with the recommendation of SEAC and decided to grant the ToR for conducting EIA studies.


