In pursuance to Meeting Notice issued vide No: EAC/JK/22/12678-12702 dated: 14/02/2022 and Corrigendum issued vide No: EAC/JK/22/12703-12718 dated 15/02/2022, the 86th Meeting of JK Level Expert Appraisal Committee (JKEAC) was held on 23rd of February, 2022 at 10:30 A.M. via video Conferencing. The Secretary, JKEAC welcomed the Chairman, Members of the JK Expert Appraisal Committee, project proponents and the consultants.

The meeting proceeded as per following sequence: -

AGENDA ITEM NO: 01

Grant of Environmental Clearance (EC) for RBM (River Bed Mineral) Minor Mineral Block Mining Project, Resized Area of 4.82 Ha., Block - 13 near Mini Secretariat Shopian Upstream Nallah Rambiara village- Arhama District – shopian UT: Jammu & Kashmir favouring M/S Abdul Hamid Wagay S/o Shri. Ghulam Nabi Wagay R/o: Narapora, District Shopian, J&K UT. shopianblock13@gmail.com

Sh. Mohammad Ghouse represented M/S Atmos Sustainable Solutions Pvt. Ltd. However, he could not present due to connectivity issues at his end. Latter Mr. M. Gilbert also tried to join. However, he too faced similar issues. The Committee observed that though the Consultant was required to submit the KML file, ppt, site appreciation note etc. 3 days before the meeting, yet it was only received half an hour prior to the scheduled meeting time today. The Committee expressed its dismay at the lackadaisical and irresponsible approach of the consultant who had failed to diligently perform his duty, thereby putting the project proponent at undue disadvantage. The project proponent informed the Committee that he had fulfilled all the formalities. He further said that his LoI was expiring on 31/03/2022 and if his case is not appraised he would suffer an irreparable loss for the fault of his consultant. The Committee took a considerate view and desired listing of the case in the next scheduled meeting through an addendum.

DELIBERATIONS/SPECIFIC OBSERVATION(S) OF COMMITTEE, IF ANY:

- a) The case had been discussed by the Expert Appraisal Committee earlier during the 20th Meeting held on 26/11/2020 during which the Committee recommended the project for grant of ToRs.
- b) The Google image of June 2017 and Sept., 2018 shows a tin shed within the mining block over a manmade channel. <u>The Committee observed that it could be a water Mill as the source of water was channelizijg through it. The same was confirmed by the consultant. The Committee observed that if it is so then mining activity may adversely affect the functioning of the Mill. Therefore, it was desired that the PP should obtain a detailed report with NOC from the concerned Tehsildar and Irrigation Dept with consent from the owner of the water Mill.</u>
- c) Features indicative of illegal mining were observed inside and outside the designated mining block which needs clarification from the Multi Dept. District Level Task Force Cell and report whether the PP is involved in it.
- d) The Consultant informed that the active water channel has been excluded while calculating the minable reserves.
- e) The Committee desired that the genuine concerns of the locals raised during public hearing should be addressed by the PP.
- f) The Committee desired that the PP should submit specific NOCs especially from PHE, Irrigation & Flood Control Dept. as the NOCs submitted are general in nature.
- g) The Committee examined the NOC issued by the Fisheries Dept. and observed that the Fisheries Dept. has stipulated condition that the main water channel should not been disturbed leaving a buffer of 30m in lean season and 50 m in peak season. Therefore, the Committee after examining the mining block on the Google Image in the light of such stipulations, desired that the PP should get the mining block resized to two subsets on either side of the water channel passing through the middle of the mining block leaving the prescribed buffer zone which approximates 3 Ha area. This should also take care of the inlet supplying water to the water Mill and its structure while following the prescribed National norms.
- h) The PP shall also submit revised haulage routes catering to the two subsets of the mining block so as to avoid crossing of the main water channel / water course.
- i) The ToR condition relating to submission of photographs of display screen of the air quality monitoring station showing data with dates of collection of the baseline data has not been submitted in the EIA report and the same needs to be submitted.
- **j**) Revision of the mining plan with mine closure plan, revised mining depth, surface area plan, targeted mineral production and replenishment and its denovo approval by the competent authority.
- k) EMP Budget needs to be revised with appropriate budget.
- Mining depth of 2.5 m & bulk density of 2.3 adopted in the instant mining plan were not agreed by the committee. Mining depth be restricted to max. 1m in aggregate and bulk density of 2.0 only be adopted for calculating the production targets in absence of actual field measurements.

RECOMMENDATION OF THE COMMITTEE

In view of the above deliberations / observations made by the Committee herein above, the Expert Appraisal Committee did not recommend the case for grant of EC in the present form. However, the PP if he so desires, may again approach the JKEIAA for grant of EC after submitting compliance to the observations made herein above under deliberations.

DELIBERATIONS/SPECIFIC OBSERVATION(S) OF COMMITTEE, IF ANY:

- a) The project had earlier been discussed during 13th meeting held on 03.10.2020 during which the committee recommended TORs to the project subject to detailed impact study of loaded tippers and other traffic on the terrain **and report of Sub-Committee of JKEAC to be constituted for site visit,** once the PP applies for EC, to have an overall assessment of the impacts of all the mining projects in the area and to recommend acceptance of EIA/EMP prescriptions or out righty reject the cases or recommend appropriate mitigative measures to preserve the fragile ecology of the area.
- b) The case was discussed for the grant of EC during the 66th meeting held on 21-10-2021 during which the committee did not approve the case & desired prior action on following points:
 - i) Submission of detailed chapter on impact of transportation of mineral on the local environment owing to fragile geology, narrowness of roads and steep gradient.
 - Obtaining of information on present status of the irrigation network executed under DPAP programme in Mahore- Dharmari area under various schemes of the Govt. by G&M Dept.
 - iii) Obtaining of opinion from G&M Dept. whether the area is fit for mining activity and that excavation in the deep Nalas will not trigger landslides.
 - iv) Exclusion of active water channel while calculating targeted mineral production.
 - v) Obtaining of title verification from the concerned revenue authority.
 - vi) Compliance to specific ToR condition relating to photographs of display screen of the air quality monitoring station displaying the dates of collection of data.
 - vii) Revision of project cost.
 - viii)Revision of the mining plan with mine closure plan, revised mining depth, surface plan, area, targeted mineral production and replenishment and its denovo approval by the competent authority.
- c) During deliberations in the instant meeting, the Committee decided that before going ahead, the following subcommittee is constituted to conduct site visit for making recommendations as was decided earlier in the 66th meeting in this regard : -

- a) The project had earlier been discussed during 10th meeting held on 06.08.2020 during which the committee recommended TORs to the project subject to detailed impact study of load bearing and carrying capacity of the area to sustain mining activity and conduct of site visit by a Sub-Committee of JKEAC to be constituted to have an overall assessment of the impacts of all the mining projects in the area, after the PP applies for EC, in view of fragile ecology of the area which being highly landslide prone.
- b) A detailed impact study of traffic on the terrain of the area has been done separately which forms a part of EIA report.
- c) The case comes again for the grant of EC during the 66th meeting held on 21-10-2021 during which the committee did not approve the case & desired prior compliance to following observations:
 - i. The Committee opined that on account of the fragile geology prevalent in the area and the comparatively narrowness of the roads marked with steep gradient, the detailed assessment of impact resulting from increased traverse of heavy loaded vehicles is pre-requisite for objective appraisal of the proposal. On submission of the Impact Assessment study described herein above, the PP may approach JKEIAA for taking up the site visit by JKEAC Sub-Committee to be constituted subsequently.
 - ii. The Committee had desired the Geology & Mining Department to get a detailed ecological study done through an expert research institution of repute to determine the cumulative impact of mining activity on the fragile geology of the area as there is apprehension that such mining activities may trigger landslides in the area. Action on this count may be sought from the G&M Dept.
 - iii. The G&M Dept. may obtain the present status of the irrigation network executed in Mahore-Dharmari area under various schemes of the Govt. The Committee is given to understand that most of the irrigation network created under DPAP programme is presently defunct or only partly functional due to spate of slips & slides at the take-off points.
 - iv. Keeping in view the past experience of mining activity in hilly areas, the G&M Dept. may be asked to convey its considered opinion whether the area is fit for mining activity and that excavation in the deep Nalas will not set off landslides.
 - v. A considerable area of the mining block falls under active water channel which needs to be excluded while calculating targeted mineral production. However, as per the EIA document/PFR, the consultant has calculated the targeted mineral on the entire area that includes even the active water channel.
 - vi. The NOCs have been obtained individually from the concerned Depts. The title of the land under the block has not been got verified from the concerned revenue authority for which action needs to be taken.

DELIBERATIONS/SPECIFIC OBSERVATION(S) OF COMMITTEE, IF ANY:

- a) The project had earlier been discussed during 24th meeting held on 19.01.2021 during which the committee recommended TORs to the project subject to resizing of the mining block to maintain a safe distance of 500 mts from the bridge. The project proponent has applied afresh after resizing the mining block.
- b) The case came to be listed again for the grant of EC during the 68th meeting held on 30-10-2021 during which the committee did not approve the case & desired prior compliance to following observations:
 - i) Existence of school in the neighborhood and reservations expressed by teacher during public hearing to be addressed.
 - ii) The District Administration should prescribe a specific haulage route which minimizes the problem of noise and air pollution in consultation with the local school authorities.
 - iii) Clarification from DMO concerned w.r.t use, nature and legal status of the structures observed in the close vicinity of the mining block.
 - iv) Preventive/protective measures to minimize the pollution resulting from mining operations need to be proposed and cost thereof provided in the EMP budget.
 - v) The PP needs to propose mining in dry shoals only and where crossing of active channels is unavoidable, scientific methods which minimize the disturbance of natural flow need to be proposed / adopted.
 - vi) Securing of non-involvement in illegal mining certificate from the competent authority.
 - vii) Securing a 'fit for mining certificate' from G&M Dept. to the effect that adequate replenishment has taken place and there is enough material available in the proposed mining block that can be excavated without endangering ecological and hydrological regime of the area.
 - viii) Compliance to specific ToR condition relating to photographs of display screen of Air Quality Monitoring Station displaying the date of collection of data.
 - ix) Revision of project cost.

- x) Revision of the mining plan with mine closure plan, revised mining depth, surface plan, area, targeted mineral production and replenishment and its denovo approval by the competent authority.
- c) During deliberations in the instant meeting, the Committee observed as under:
 - i) With respect to item i, SHMI school has furnished NOC vide letter no. 122/SHMI/spn/21 dated 23-11-2021 in favour of mining block based on certain terms & conditions to be fulfilled prior to & during execution of mining process.
 - ii) With respect to item ii, a specific haulage route in consultation with school authorities has not been provided.
 - iii) The Committee desired that the PP should get clarification from the District Adm. stating that the mining activity shall not have any adverse impact on the local environment especially environment of the school and that the haulage shall be exclusively from the District Police Lines side and not from the school side.
 - iv) With respect to item iii, regarding clarification about the use, nature and legal status of the structures observed in the close vicinity of the mining block, it is not required now as the point is irrelevant due to resizing of the block.
 - v) With respect to item iv, the PP has proposed preventive/protective measures in the EMP budget to minimize the pollution resulting from mining operations.
 - vi) With respect to item v, the PP has not excluded the active water channel portion from the mining block while calculating the mineral reserves.
 - vii) With respect to item vi, the (MDLTF) cell report, issued by District Magistrate, Shopian Vide letter no. DMS/PP/21/4237-39 dated 04-02-2022 clearly indicated the non-involvement of PP in the illegal mining activity.
 - With respect to item vii, The PP has obtained '*fit for mining certificate*' from G&M Dept. issued by DMO, Shopian vide letter no. DMO/DGM/spn/1026-27 dated 29-11-2021.
 - ix) With respect to item viii, the compliance to specific ToR condition relating to photographs of display screen of air quality monitoring station is awaited.
 - x) With respect to item ix, the project cost has been revised.
 - xi) With respect to item x, revision of the mining plan is awaited.

RECOMMENDATION OF THE COMMITTEE:

In view of the above deliberations and insight gained during the above cited appraisal process, the Committee did not recommended the case for the grant of environmental Clearance in the present form.

However, the PP if he so desires may again approach JKEIAA after obtaining compliance to the above observations.
