

**MINUTES OF THE 101ST GOA STATE ENVIRONMENT IMPACT ASSESSMENT
AUTHORITY (GOA-SEIAA) MEETING HELD ON 28/04/2023 AT 11:30 A.M. IN
THE CONFERENCE ROOM OF THE 4TH FLOOR, DEMPO TOWER, PATTO,
PANAJI-GOA**

The 101st meeting of the Goa - SEIAA (*hereinafter referred as 'Authority'*) was held on 28th April 2023 at 11:30 am in the conference room, 4th floor, Dempo Tower, Patto, Panaji. The list of members present during the meeting is annexed (*refer Annexure - 1*).

At the outset, Chairman welcomed Authority members and briefed about the agenda items (*refer Annexure - 2*) to be taken up for discussion / deliberations and suitable decision. Accordingly, the same were considered as detailed below.

1. To decide on application received from M/s Vibhav Real Estate and Madanant Constructions (Goa) Pvt. Ltd. in property bearing Survey No. 192/1-C, Ponda Goa for prior Environment Clearance

The Propject Proponent Shri. Sudin N. Verekar along with his consultant Shri. Omkar Jog appeared before the Authority.

Decision: After going through the presentation by the Project Proponent, the Authority decided to raise the following ADS:

- i. Details regarding Disposal of Organic (wet) waste.
- ii. Details regarding installation of solar panel.
- iii. Details regarding parking.
- iv. Details pertaining to recharge pit for rainwater harvesting.
- v. Physical copy of the conceptual building plan.
- vi. Details regarding the plot area, built up area and open area.

2. Any other matter with permission of the chair.

i. Clarification regarding categorization of project (B1 & B2) with respect to Sand Extraction proposal

The matter was taken up in the meeting for discussion and to take decision.

As referred to the order issued by Hon'ble NGT dated 17/03/2023, it is noted that no permit for sand extraction would be issued by this Authority till the final hearing takes place i.e. upto 17/05/2023.
