Hence, replenished quantity of sand i.e. 383.43cum/year may be considered for removal subject to outcome of further replenishment studies.

Now they have applied for modification of EC along with the replenishment study report and applied for less capacity than the approved capacity i.e. **3069.6 cum/annum**. The replenishment study undertaken only after post monsoon. The Pre-monsoon data is required to estimate the difference. Thus, it is recommended to submit complete and correct and complete replenishment study for taking decision.

- (v) **Water requirements and Wastewater generation** – Total water requirement for the project is 347KLD. Out of 347KLD, total fresh water requirement will be 229.0 KLD and for flushing will be 118KLD. The source of water is Surface Water. It is expected that the project will generate approx. 324.1 KLD of wastewater. The wastewater will be treated in the STP of capacity of 400 KLD provided within the complex. - (xi) Solid waste Generation: From the residential complex solid waste in form of food waste from kitchen and miscellaneous waste will be generated @ 0.45 kg/person/day, which will be about 1105.2 kg/day. The generated solid waste from the residential complex will be segregated as biodegradable and non-biodegradable. This will be collected in separate colored bins. Proper waste management practices will be adopted during the collection, storage and disposal of the generated solid waste and construction and demolition waste. Solid waste from sweeping and Dry Garbage containing non bio degradable wastes like polythene bags, metal, ceramic Waste, glass etc. shall be stored in separate garbage bin and send to approved recyclers.

- (xiii) Project cost - The estimated project cost is around Rs 73.0 Crores while Environment Management Capital Cost is 90 Lakhs and recurring Cost is 17.2 Lakhs.
- (xiv) The Environment consultant Centre for M/s Centre for Envotech and Management Consultancy Pvt. Ltd., Bhubaneswar, along with the proponent made a presentation on the proposal before the Committee on 23.12.2022.






