Actions on the recommendations of 14th Meeting of SEAC to be held on 27th Jan, 2021.

1. **EC for collection of sand from Kopili River bed “Chaparmukh- Kopili Nodi Sand permit area 1(B) under Nagaon Forest Division by Imanul Haque. SEIAA.1033/2020 (Proposal no. SIA/AS/MIN/44158/1900)**

SEAC Resolution 14/2:

The project proposal requesting for extension of EC submitted by Md. Inamul Haque to extract sand from “Chaparmukh Kopili Nodi Sand Permit Area 1 (B)” under Nagaon Forest Division is deliberated in the SEAC meeting. On scrutiny of the records and the approved Mining Plan, it is revealed that the earlier EC was granted from the District Level Committee allowing one year time. The concerned Divisional Forest officer recommended for extension of the EC till 27th March 2021 as per contract terms. Considering the fact stated above, the SEAC committee approved the proposal to extend the **EC to extract the balance quantity of 2700 cu.m. sand from the proposed site within 27-03-2021** strictly following the terms and condition laid down in the approved mining plan. 3. **EC for collection of Brick Earth from “1 no Borgoya Gaon Brick Earth MPA (P.P land) under Majuli (T) forest Dvn by M/S RBI Brick Industry. (SEIAA.1429/2020) (Proposal no. SIA/AS/MIS/ 148519/2020**

SEAC Resolution 14/4:

The project proposal for extraction of brick earth from “1 no. Borgoya Gaon Brick Earth MPA (P. P. Land)” under Majuli (T) Forest Division submitted by Sri Ratul Bhuyan, Prop. M/S RBI Brick Industries is discussed in the SEAC meeting. Due scrutiny of the documents are made and considering the recommendation of the DFO as well as the approved mining plan, the proposal is approved to extract 11200 cu.m. brick earth from the proposed location in two years. 
- The maximum mining depth will be 1 (one) meter.
- The executive agency should not cut the embankment to construct ramp.
- Extraction of earth /clay should be **carried out beyond 100 m.** from the existing embankment.
- Excavation should be carried out intermittently leaving a space of 5 mt. on every side of each borrow pit. The size of the borrow pit should not exceed 20mt. X 10 mt.
- EC be allowed for mining till 15th April 2021.
- In addition to the above, the PP shall have to strictly follow the terms and condition laid down in the approved mining plan.

The Divisional Forest Officer, North Kamrup Division shall ensure due surveillance on the mining operation to avoid occurrences of irregularities during the mining period.
