Hence the Authority decided to refer back this proposal to SEAC with a direction to obtain the Conservation Plan from PP, examine and then send the proposal to SEIAA for further action.

The Authority further directed that all those proposals which fall outside the ESZ but are within 10 km of a National Park/Wildlife Sanctuary/ Tiger Reserve/Conservation Reserve must necessarily submit a conservation plan for the area.

- 6. Serial No. 32: In this proposal DSR submitted is of Marble but the proposal is for granite. Also the LoI of the proposal has expired. Hence the Authority decided to defer this proposal for additional information to be submitted within 45 days.
- Serial No. 37 to 41 & 43: The Authority accepted the recommendations of SEAC and decided to grant amendment in EC to these proposals with the additional conditions imposed by SEAC.
- 8. Serial No. 42: In this proposal, as per the KML, lease area coordinates are falling within the forest area, Moreover, in form I it is mentioned that Raghunath PF is

adjoining to the lease area but no exact distance is mentioned neither in Form I nor in DCF Letter and in DCF Letter lease area is mentioned as 1023.27 ha instead of 2932.924 na.

Also, it is mentioned in DCF Letter that Shakambari CR and Bansiyal-Khadi-Bagore CR falls within 10 km radius of the lease area but no exact distance is mentioned. Hence, the Authority <u>decided to defer this proposal</u> for submission of revised DCF letter stating distance from the nearest forest as well as from Shakambari CR and Bansiyal-Khadi-Bagore CR within 45 days.
