4. Serial No. 4: Proposal was deferred in 5.125th meeting of SEIAA for submission of Affidavit regarding no violation and ATR for non-complied conditions in the submitted CCR.

Now, PP has submitted the requisite documents. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to <u>approve</u> <u>EIA/EMP and grant EC</u> to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

5. Serial No. 5: Proposal was deferred in the 5.117th meeting of SEIAA for personal hearing to respond to inadequate parking and submission of an affidavit regarding "No spillover of vehicles outside the project premises"

PP was heard during the presentation and the Authority is of the view that the proposed project is in dense commercial area wherein provision of inadequate parking in a proposed commercial complex would have an adverse impact on the Traffic Circulation System and connectivity. Accordingly, PP was directed to increase parking provisions in accordance with the NBC norms and to submit an affidavit that there will be no spill over of the vehicles outside the premises on the road. Hence, the Authority decided to <u>defer</u> this proposal for submission of additional information within next 45 days.

6. Serial No. 6: Proposal was deferred in the 5.124th meeting of SEIAA as in this proposal, affidavits submitted by the PP and Consultant do not state anything on the compliance or non-compliance of Common Cause judgment of the Hon'ble Supreme Court in their affidavits.

Now, PP has submitted the affidavits with the same deficiency again. The Authority was of the view that as this declaration regarding the Compliance of the Hon'ble Supreme Court Judgement dated 02.08.2017 passed in Common Cause vs. Union of India Writ Petition (C) 114 of 2014 is a mandatory requirement but even after a giving an opportunity, PP has not submitted the same. In view of this, the Authority decided to <u>defer this proposal and issue a Show Cause notice against</u> the PP and Consultant.

Transfer of Environmental Clearance (From M/s Gomti Marble to M/s Shree Maruti Nandan Marble) issued by DEIAA, Rajsamand vide letter dated 06.07.2016 for M.L. No. 231/1998, Production Capacity- 29988 TPA for Marble Mining Project Near Village-Nizarana, Tehsil-Rajsamand, District- Rajsamand (Raj.) (Proposal No- 467310)

The Authority after detailed discussion and deliberation decided the following:

 Serial No. 1: Proposal was deferred in the 5.125th meeting of SEIAA for submission of revised parking in accordance with the Authority's MOM dated 15.09.2023 along with CGWA application for the required fresh water.

Now, PP has submitted the revised parking provisions i.e., 180 ECU (161 Cars and 57 Scooters) along with the copy of application submitted to CGWA for the requirement of 83 KLD fresh water. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

2. Serial No. 2: Proposal was deferred in the 5.125th meeting of SEIAA as this proposal seemed to be an apparent case of attempting to evade prior EC and commencing construction. PP was asked give explanation why the case should not be treated as a case of violation.

Now, PP has submitted the reply with his clarification but the Authority found the reply as inadequate. Hence the Authority decided to <u>defer</u> this proposal and call PP to explain why this project is not in violation of the MoEF&CC OM dated 29.03.2022.

 Serial No. 3: Proposal was deferred in 5.124th meeting of SEIAA for submission of Affidavits regarding no violation and implementation of Cluster EMP.

Now, PP has submitted the requisite documents. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

7. Serial No. 7: This pertain to <u>re-appraisal of EC</u> issued by the erstwhile DEIAAs. Proposal was deferred in the 5.125th meeting of SEIAA for submission of revised DCF certificate stating clearly whether the lease falls in the ESZ or not and submission of Conservation Plan.

Now, PP has submitted DCF WL Abuparvat Sirohi letter dated 11.03.2022 stating that Project site is at a distance of 2.05 km from Mount Abu WLS - 2.05 km and is outside the ESZ. PP has also submitted the receipt of Conservation Plan from the concerned DCF office. Hence, the Authority accepted the recommendation of SEAC and decided to **grant EC** to this proposal.

 Serial No. 8: Proposal was deferred in the 5.125th meeting of SEIAA for submission of conservation Plan, Cluster Certificate & ATR for non-complied conditions in submitted CCR.

Now, PP has submitted the requisite documents. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

- Serial No. 9: The Authority accepted the recommendations of SEAC and decided to close and delist this proposal.
- 10. Serial No. 10, 16, 17, 18, 19, 20, 21, 25, 27, 31: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to these proposals.
- 11. Serial No. 11 & 12: In these proposals, SEAC has recommended to close & Delist these proposals. The Authority is of the view that <u>PP may be called for personal hearing</u> along with the documents showing separate administrative and financial sanction by the competent authorities in RIICO for phase-wise development along with the category of the industries proposed in the industrial area in order to establish that this is not a case of violaton.
- 12. Serial No. 13: In this proposal, Bandh Baretha WLS is within the 10 km of the lease area but no Conservation Plan has been submitted for the same. Hence, the Authority decided to <u>defer</u> this proposal for submission of additional information i.e., Conservation Plan with its submission receipt from the concerned DCF office, in next 45 days.



- 13. Serial No. 14: In this proposal, PP has not submitted the complete copy of Approved Mining Plan. Hence, the Authority decided to <u>defer</u> this proposal for submission of additional information i.e., copy of Approved Mining Plan, in next 45 days.
- 14. Serial No. 15: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant Amendment in EC to this proposal.
- 15. Serial No. 22: The Authority decided to <u>defer</u> this proposal for submission of proper WRD Certificate stating that the proposal does not infringe with the direction of Hon'ble High Court in the matter of Abdul Rehman.
- 16. Serial No. 23, 29, 30, 32, 33, 35: The Authority accepted the recommendations & additional conditions of SEAC and decided to <u>approve EIA/EMP and grant EC</u> to these proposals with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 17. Serial No. 24: In this proposal, Consultant has not stated anything in their affidavit on the compliance or non-compliance of Common Cause Judgement of the Hon'ble Supreme Court. Hence, the Authority decided to <u>defer</u> this proposal for submission of affidavit in the prescribed format, within 45 days.
- 18. Serial No. 26: In this proposal Lease Sanction order has been expired on 06.01.2024 and in Approved Cluster Mining Plan, proposed production capacity of cluster is not mentioned. Hence, the Authority decided to <u>refer back</u> this proposal to SEAC to examine whether PP has any valid lease documents as on date along with revised approved Cluster Mining Plan.
- 19. Serial No. 28: The Authority decide to <u>refer back</u> this proposal as there is variance in the abstract and the minutes of the SEAC. However, SEAC may also examine whether the PP needs to apply fresh in her name after getting the lease transferred.
- 20. Serial No. 34: In this proposal, PP has submitted DSR of Jaipur district in place of Alwar district. Hence, the Authority decided to <u>defer</u> this proposal for submission of additional information i.e., DSR of Alwar district within 45 days.
- 21. Serial No. 36, 37, 39, 40, 41, 43, 50, 51, 52: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per

MoEF&CC OM Dated 28.04.2023, Hon'ble NGT order dated 07.12.2022 and SOP dated 15.01.2023 issued by MoEF&CC.

22. Serial No. 38, 42, 47, 48, 49: The Authority decided to grant Transfer EC to these

proposals.

23. Serial No. 44, 45, 46: PP requested to withdraw the proposal of transfer EC. Hence,

The Authority accepted the request and decided to close and delist this proposal.

24. Additional Agenda:

"National Green Tribunal Principal Bench, New Delhi order dated 31.05.2024 in

the matter of Jayant Kumar vs. MoEF&CC- I.A. No. 262/2024 and I.A. No.

263/2024 in Original Application No. 142/2022."

In compliance of the directions of Hon'ble NGT vide order dated 31.05.2024, the

Authority discussed the said 11 proposals of the applicants mentioned in the NGT

order and was of the view that Intimation Number may be generated and decided to

direct the PP to apply on Parivesh Portal 2.0 to expedite the process in compliance of

Hon'ble NGT order dated 31.05.2024. Also, SEACs are directed to consider these

proposals out of turn in their very next meeting once PP have applied/submitted EDS

reply on the Parivesh Portal.
