

The SEIAA discussed in detail and based on the recommendations of SEAC, ADS reply dt: 25.06.2025 wherein it is submitted that the EMP is revised with a capital cost Rs. 11.50 Lakhs & Recurring cost Rs. 5.60 Lakhs. However, it is noted that the proponent has not signed the revised EMP. Hence, approved the project for Environmental Clearance subject to submission of revised EMP duly signed by the proponent, along with the following additional conditions:

1. The proponent shall implement occupational health and safety to the employees and provide insurance.
2. The proponent shall transfer money through online/cheque only for CSR activities.
3. The proponent shall maintain the photographic evidence of CSR activities.
4. The proponent shall implement waste management plan.
5. The proponent shall develop greenbelt along the boundary and approach road.
6. The proponent shall comply to Ministry's OM dt:24.07.2024 for plantation in the earmarked green belt area as part of tree plantation campaign "Ek Ped Maa Ke Naam".
7. The project proponent shall upload self-certification report in the parivesh portal as per format every year on 1st June and 1st December.
8. The proponent shall carry out ambient air quality monitoring by NABL approved laboratory and submit the reports every quarterly.
