### **Minutes of the 745<sup>th</sup> Meeting of the State Level Environment Impact Assessment Authority, UP (SEIAA) held on 28-06-2023**

The meeting of 745<sup>th</sup> State Level Environment Impact Assessment Authority, UP (SEIAA) was held on-line on 28.06.2023 the Directorate of Environment. The following were present in the meeting:-

1. **Proposed of Ordinary Soil Mining Project at Gata No.- 43, 127/Ya, 208, 126mi, 153, 154, 155, 157 mi, 191, 195, Village – Daulatpur Mu. , District- Shahjahanpur, U.P., Area- 4.935 ha. File no- 7332**

SEIAA gone through the mail dated 30.04.2023 of project proponent requesting to correct the validity period of EC dated 17.03.2023. SEIAA gone through file and documents and agreed to correct the validity period of EC dated 17.03.2023 from 3 months to 6 months.

2. **Proposed "Building Stone as Sandstone Khanda, Boulder, Gitti Mining Project" located at Arazi No. 508/1 Village- Dadiram, Tehsil- Sadar, District Mirzapur, Uttar Pradesh,(Area- 0.626 Ha.) File no- 7879.**

SEIAA noted that the above project was taken in its 742 meeting in which SEIAA opined that the project proponent shall submit documents regarding DSR. The project proponent has submitted his reply vide letter dated 20.06.2023.

In light of discussion held in SEIAA meeting no. 597 dated 05.05.2022. SEIAA opined to accept the recommendation of SEAC and grant EC to the said project along with all the general and specific conditions as suggested by SEAC but SEIAA replaces the specific condition regarding cluster certificate as "If in future during the progressive mining this lease area becomes part of cluster i.e. area equal to or more than 5 ha., limited to B-1 category, then additional conditions based on the EIA conducted by the concerned lease holders shall be imposed and joint EMP shall be implemented. The lease holder shall mandatorily follow all the imposed conditions otherwise it will amount to violation of E.C. conditions. If the certificate related to cluster provided by the competent authority is found false or incorrect then punitive actions as per the law shall be initiated against the authority issuing the cluster certificate" and adding following conditions:-

1. Validity period of this EC is 5 years from the date of issue as the Lol has been issued for a period of 5 years or co-terminus with the validity of current mine plan or current lease period whichever is earlier. After this period the EC will become null and void.





2. A certificate from Forest Department shall be obtained that no forest land is involved in mining or as a route and if forest land is involved the project proponent shall obtain forest clearance and permission of Central and State Government as per the provisions of Forest (conservation) Act, 1980 and submit before the start of work.
3. The mining lease holders shall, after ceasing mining operations, undertake re-grassing the mining area and any other area which may have been disturbed due to their mining activities and restore the land to a condition which is fit for growth of fodder, flora fauna etc.
4. Three tier green shelter belt of 7.5m width should be developed on the periphery of mine lease area. Local and native species should be planted in consultation with Forest/Horticulture Department/Agriculture University.
5. Plan for using the mine void for productive use in consultation with local administration and gram-panchayat.
6. If the proposed project is situated in notified area of ground water extraction, where creation of new wells for ground water extraction is not allowed, requirement of fresh water shall be met from alternate water sources other than ground water or legally valid source and permission from the competent authority shall be obtained to use it.
7. Project Proponent should submit action plan for carrying out plantation at least @1,000 plants / ha of lease area. In this case, PP should prepare a plan, duly approved either by Forest Department or Horticulture Department, for planting at least 1000 plants, either on government land or community land, within a periphery of 5 km from the boundary of the lease area along with provision for maintenance for 5 years. Survival of plants should not be less than the survival rate notified by Uttar Pradesh Forest Department otherwise it will be treated as violation of EC condition.
8. In consultation with District Environment Authority or an Authority nominated by concerned DM, project proponent will prepared a conservation and management plan for rejuvenation and management of water bodies having total surface area of more than 5 ha. Funds for the same will be kept in a separate bank account and six monthly compliance status will be presented by project proponent before the nominated authority in the District.
9. Department of Geology and Mines, Government of Uttar Pradesh and / or concerned district administration, before releasing the security deposit to Project Proponent will ensure that Project Proponent has fully complied with the EC conditions. Non-compliance, if any, should be reported to UPSPCB for appropriate legal action and recovery of compensation.
10. Any application for transfer of this EC, during its validity period unless it is cancelled by a competent authority, has to be necessarily accompanied with status of compliance of EC conditions duly certified by IRO, MoEFCC, GoI, Lucknow.
11. Number of mining projects are coming up in district. Department of Geology & Mines, GoUP to carry out regional EIA-EMP report including carrying capacity of environmental components to assess the capacity to further bear the pollution load for such areas within a period of 1 year and submit the same to SEIAA, UP for evaluation.

3. **Construction of Rubber Dam at 1.5 Km downstream of Taj Mahal on River Yamuna in Agra City, District- Agra, U.P., Shri Anil Kumar, Chief Engineer. File No. 5717/ Proposal No. SIA/UP/MIS/161987/2020**

SEIAA noted that the above project was taken in its 665 meeting in which SEIAA required following—

1. PP to submit Air Pollution Score, duly verified either by CPCB or UPPCB, for the said project.
2. PP to submit NoC from TTZ Authority for establishing said project
3. PP to submit compliance report on sectoral guidelines, when the same are notified by MoEFCC

The project proponent has submitted his reply vide letter no. 2318/Mu.A.Y/Rubber Dam/MoEF dated 08.05.2023. Hence SEIAA agreed with the recommendation of SEAC to grant EC to the above project.

SEIAA noted that the above project was taken in its 673 meeting in which SEIAA noted that in LOI the quantity has been mentioned as 8,090 m<sup>3</sup> whereas in mine plan approval letter the quantity has been mentioned as 16,180 m<sup>3</sup> therefore Project proponent/consultant to get these documents corrected and submit to SEIAA. Project proponent has submitted corrigendum letter 1805/M21/2018(E.P.kha.Yo.) dated 28.02.2023

In light of discussion held in SEIAA meeting no. 597 dated 05.05.2022. SEIAA opined to accept the recommendation of SEAC and grant EC to the said project along with all the general and specific conditions as suggested by SEAC but SEIAA replaces the specific condition regarding cluster certificate as "If in future during the progressive mining this lease area becomes part of cluster i.e. area equal to or more than 5 ha., limited to B-1 category, then additional conditions based on the EIA conducted by the concerned lease holders shall be imposed and joint EMP shall be implemented.
