recommendation of SEAC to grant the environmental clearance to the above project along with the following additional specific conditions:-

- Project proponent shall carryout the analysis for aquatic and soil inhabitant, along with subsurface water samples for environmental parameters/contaminants effecting the ecological system if any. Water and soil test samples shall be collected and be analyzed for at least of two site stations of the river/natural water bodies, distance admeasuring approximately 100 mt apart from one another., and likewise for subsurface water, at least two subsurface water sample shall be collected from both bank side of the river/natural water bodies, trans distance admeasuring approximately 500mt., apart in the traverse journey of Expressway road/bridge width.
- Project proponent shall assess the impact of Elevated road construction on migratory birds under the direction and supervision of Chief Wildlife Warden of Govt. of U.P.

The lease holder shall mandatorily follow all the imposed conditions otherwise it will amount to violation of E.C. conditions. If the certificate related to cluster provided by the competent authority is found false or incorrect then punitive actions as per the law shall be initiated against the authority issuing the cluster certificate". And adding one condition:- The project proponent shall obtain the forest clearance and permission of Central and State Government as per law under the provisions of Forest (conservation) Act, 1980 before the start of work.

The proposed project is under Red/Orange category of industrial Sectors and exists in the Critically Polluted Industrial Areas (CPAs) as notified by MoEF&CC, Govt of India. The present project is categorized under B2 category according to the provisions of EIA notification 14 September, 2006 (As amended thereof). SEIAA noted that above case was taken in its 334thmeeting dated 08/01/2020 in which SEIAA opined that concurrence with Central Empowerment Committee and opinion of NEERI shall be taken by the project proponent.

SEIAA reviewed the case and agreed with the recommendation of SEAC 376th meeting dated 12/12/18 in which SEAC has recommended to grant modification of environmental clearance to the above project along with all the general and specific conditions. In addition to the conditions imposed by SEAC the SEIAA added following additional specific conditions:-

- This modification of environmental clearance shall be subjected to order of the Hon'ble Supreme Court dated 06/12/2019 passed in IA no- 103908 of 2019 in Writ Petition Civil no-13381 of 1984 M.C. Mehta V/s Union of India & others. This modification of EC shall be valid only after the concurrence of Central Empowerment Committee and opinion of NEERI is obtained by the project proponent. The additional conditions if any imposed by Central Empowerment Committee and opinion of NEERI shall automatically become part of EC and shall be strictly followed by the project proponent.
- Project proponent shall submit concurrence of Central Empowerment Committee and opinion of NEERI to SEIAA before start of work related to this amendment of EC. The SEIAA reserve all right to add additional conditions keeping in view the concurrence of CEC and opinion of NEERI.
- If the work is started in violation of above condition than the EC shall be revoked and action shall be taken against Project Proponent under relevant provision of EPA 1980 (as amended).
- Since the proposed project falls in Critically Polluted Areas (CPAs), Severely Polluted Areas (SPAs) the provision of the mechanism farmed regarding compliance of Hon'ble NGT order in OA 1038/2018 dated 19-08-2019 by MoEF& CC, Govt. Of India vide letter dated 31-10-2019 shall be followed in letter and spirit.

- 5. All the additional condition for grant of Consent to Establish (CTE)/Consent to Operate (CTO) related to Pollution mitigation measures as prescribed in the office memorandum of MoEF&CC, Gol. dated 31.10.2019 and as deemed fit by UP Pollution Control Board in the consent orders shall be followed by Project Proponent.
- 6. The project proponent shall submit within the next 3 months the details of solar power plant and solar electrification details within the project.
- The project proponent shall ensure to plant broad leave trees and their maintenance. The CPCB guidelines in this regard shall be followed.
- 8. The project proponent shall submit within the next 3 months the details on quantification of year wise CER activities along with cost and other details. CER activities must not be less 2% of the project cost. The CER activities should be related to mitigation of Environmental Pollution and awareness for the same.
- 9. The project proponent shall submit within the next 3 months the details of estimated construction waste generated during the construction period and its management plan.
- 10. The project proponent shall submit within the next 3 months the details of segregation plan of MSW.
- 11. The project proponent shall ensure that waste water is properly treated in STP and maximum amount should be reused for gardening flushing system and washing etc. For reuse of water for irrigation sprinkler and drip irrigation system shall be installed and maintained for proper function. Part of the treated sewage, if discharged to sewer line, shall meet the prescribed standards for the discharged. Under any circumstances untreated sewage shall not be reused or discharged to municipal sewer line.
- 12. The project proponent will ensure that proper dust control arrangements are made during construction and proper display board is installed at the site to inform the public the steps taken to control air pollution as per the Construction and Demolition Waste Management Rules.
- 13. The project proponent shall install micro solar power plants, toilets in nearby villages, public place or school from CER fund of the project for which E.C is granted in addition to and water harvesting pits and carbon sequestration parks / designed ecosystems.
- 14. The project proponent shall obtain the forest clearance and permission of Central and State Government as per law under the provisions of Forest (conservation) Act, 1980 before the start of work.
