SEIAA gone through the recommendation of SEAC. It mentions that earlier EC was issued on 22/03/2012 for plot area 6,18,952.80 and built up area 5,35,581.20 m² respectively. The project proponent has submitted online application on 12/10/2019 for EC of plot area 1,61,820.00 m² and built up area 1,41,038 m² as a new project. The earlier EC has expired on 21/03/2019 but SEAC has advised project proponent to apply for extension of validity of EC. The recommendation is not clear. The validity extension rules are clear in EIA notification-2006 which allow only maximum three months grace period. It is also not clear whether it is same project or different project.
