

SEIAA is getting minutes of SEAC repeatedly in which the recommendations don't have any specific mention about its appraisal considering CPA/SPA regions in 13 districts as per Hon'ble NGT order passed in O.A. No. 1038/2018 dated 19/08/2019. In such situations the cases are getting referred back to SEAC for re-examination, which may cause avoidable delay in decisions on grant of ToR/EC. SEAC is advised to take note of it and to appraise the cases of CPA/SPA identified district/region as per MoEF&CC OM no. 22-23/2018-IA III(Pt) dated 31/10/2019 and mention in its minutes. So that the application of project proponents can be disposed off on an early date.
