It is requested that the Project Proponent or his/her authorized representative should participate in the presentation meeting of SEAC, who can respond or make commitment to the queries/suggestions of the Committee. The name of representatives may be communicated in advance.

For the purpose, the documents such as Form-1, Environment Impact Assessment Report, public hearing report, Action Plan on the issues raised during PH, queries (EDS and ADS) subsequently raised, if any, and your para-wise comments thereto etc., are required to be forwarded to the Chairman/Members of the SEAC

Also to submit the details of the court matters/Orders of the Court pertaining to the project, if any

It may be ensured that the Members receive the aforesaid requisite documents in soft copy/e-mail pertaining to the projects within a day of publishing the agenda positively. Failing which the Committee will not consider the project.

The Project Proponents shall ensure that the reports / documents uploaded in PARIVESH, circulated to the SEAC members and hard copy submitted to the Office are the same. In case of discrepancy, the project will not be considered.

The Consultant shall include an undertaking in the EIA report that the prescribed TOR have been complied with and that the data submitted is factually correct and also an undertaking shall be submitted owning the contents (information and data) in the EIA/EMP report.

- The industrial projects shall present carbon foot print, net zero/de-carbonization mechanism, carbon sequestration study etc., with respect to proposed project and their mitigation measures also needs to be included in the Presentation.
- The Infra projects shall present green building initiative.
