- The KML/Shape files should be emailed to mentioned at para No. 7 below at least 5 days prior to the meeting.***

They may also depute senior officers from the company (preferably not more than two representatives) who can make a presentation on their behalf on the salient features of the project, the related environmental issues, proposed Environmental Management Plan and also respond to the queries/suggestions of the Committee.
