

Minutes of the 721th Meeting of the State Level Environment Impact Assessment Authority, UP (SEIAA) held on 24.04.2023

The meeting of 721th State Level Environment Impact Assessment Authority, UP (SEIAA) was held on-line on 24.04.2023 the Directorate of Environment. The following were present in the meeting:-

Chairman SEIAA did not participate in the meeting. 721th State Level Environment Impact Assessment Authority, UP (SEIAA) meeting was convened and conducted in reference to the letter no. 135/81-7-2023-103(parya)/2007 dated 7-2-2023 of Department of Environment Forest and Climate Change, GoUP.

Agenda –A Reply

1. **Transfer of EC of Proposed "Ordinary Sand Mining" Project in Yamuna River at Gata No./ Khand No.-1954/2, Village- Kodra Jalalpur, Tehsil- Sadar, District-Firozabad, Shri Ajay Pal Singh (Leased Area: 5.20 Ha) File No. 4295/Proposal No. (SIA/UP/ MIN /74914/2018)**

EC in question was issued vide letter no. 294/Parya/ SEAC/4295/2018 dated 18.07.2018 for an annual production of 1,04,000 cum. Now the request for transfer of EC is for a production of 52,000 cum for a period of 6 months. First the extraction quantity to be reduced from 1,04,000 cum to 52,000 cum and then the EC be transferred for a period of 6 months. After this transfer, original EC and transfer order both will become null and void.

SEIAA opined that Environmental Clearance will be transferred only after submission of an affidavit by project proponent and consultant that:-

- a) No legal case is pending in any Court of Law against the above area / EC proposed to be transferred.
- b) EC proposed to be transferred has not been cancelled by any Court of Law/MoEFCC/SEIAA/DEIAA.
- c) EC proposed to be transferred is valid on the date of consideration.
- d) Mine plan has been transferred in the favour of present project proponent.

Further, before issuing EC transfer letter, authorized signatory from SEIAA, UP will ensure that affidavit given by PP and consultant is correct and in case affidavit given by PP and consultant is found to be false, legal action should be initiated against them and

transfer order should not be issued and in case it has been issued then it will become null and void. All EC transfer orders will be issued through online portal.

SEIAA noted that the previous lease issued to Shri Ajay pal singh S/o Shri Kartar Singh Village and post matsaina sadar Firozabad was cancelled vide DM, Firozabad order no. 56/khan nirikshak/firo/2022 dated 28.12.2022 and another LOI was issued to Shri Ashok kumar contractor S/o Shri Prithi singh 437 yadav colony bypass road Sikohabad Firozabad for a period of 6 months and 52,000 m3 production capacity vide letter no. 183/khan adhikari/firo/2023 dated 20.03.2023.

Hence SEIAA opined to transfer Environmental Clearance issued vide letter no. 294/Parya/ SEAC/4295/2018 dated 18.07.2018 Shri Ajay pal singh S/o Shri Kartar singh Village and post matsaina sadar Firozabad to Shri Ashok kumar contractor S/o Shri Prithi Singh 437 yadav colony by pass road Sikohabad Firozabad for 52,000 cum production capacity for six months. SEIAA added following conditions:-

1. Transfer of EC is granted for a period of 6 months from the date of issue or validity of current mine plan or current lease period whichever is earlier and after this the original EC and transfer order both will become null and void.
2. A certificate from Forest Department shall be obtained that no forest land is involved in mining or as a route and if forest land is involved the project proponent shall obtain forest clearance and permission of Central and State Government as per the provisions of Forest (conservation) Act, 1980 and submit before the start of work.
3. The mining lease holders shall, after ceasing mining operations, undertake re-grassing the mining area and any other area which may have been disturbed due to their mining activities and restore the land to a condition which is fit for growth of fodder, flora fauna etc.
4. If the proposed project is situated in notified area of ground water extraction, where creation of new wells for ground water extraction is not allowed, requirement of fresh water shall be met from alternate water sources other than ground water or legally valid source and permission from the competent authority shall be obtained to use it.
5. Project Proponent should submit action plan for carrying out plantation at least @1,000 plants / ha of lease area. In this case, PP should prepare a plan, duly approved either by Forest Department or Horticulture Department, for planting at least 6,000 plants, either on government land or community land, within a periphery of 5 km from the boundary of the lease area along with provision for maintenance for 5 years. Survival of plants should not be less than the survival rate notified by Uttar Pradesh Forest Department otherwise it will be treated as violation of EC condition.
6. In consultation with District Environment Authority or an Authority nominated by concerned DM, project proponent will prepared a conservation and management plan for rejuvenation and management of water bodies having total surface area of more than 30 ha. Funds for the same will be kept in a separate bank account and six monthly compliance status will be presented by project proponent before the nominated authority in the District.
7. Department of Geology and Mines, Government of Uttar Pradesh and / or concerned district administration, before releasing the security deposit to Project Proponent will ensure that Project Proponent has fully complied with the EC



conditions. Non-compliance, if any, should be reported to UPSPCB for appropriate legal action and recovery of compensation.

8. If the air quality deteriorates due to mining, then District Administration & Directorate of Mining should ensure that mining be stopped immediately. Adequate measures be taken for restoring air quality and mining should commence only when air quality attains the prescribed standards.

Rest all the content of Environmental Clearance letter no. 294/Parya/SEAC/4295/2018 dated 18.07.2018 shall remain same.

Area mentioned in the previous EC is being transferred only. If there is a change in geo-coordinates of the area then EC will be null and void.

2. Group Housing at Plot No.- A-99, Sector- 51, Noida, District Gautam Budha Nagar, U.P., Shri S.K. Sharma, M/s Uflex Ltd. File No. 6285 Proposal No. SIA/UP/MIS/208731/2021

SEIAA noted that the above project was taken in its 605th meeting in which SEIAA opined that the queries have not been replied satisfactorily. Hence the project proponent should submit complete and satisfactory reply. The project proponent has submitted his reply vide letter dated 17.04.2023. After reviewing the reply in light of discussion held in SEIAA meeting no. 597 dated 05.05.2022, SEIAA opined to accept the recommendation of SEAC and grant EC to the said project along with all the general and specific conditions as suggested by SEAC. In addition to the conditions imposed by SEAC, SEIAA added following additional specific conditions:-

1. The project proponent shall submit within the next 3 months the details of solar power plant and solar electrification details within the project.
2. The project proponent shall ensure to plant broad leaf trees and their maintenance. The CPCB guidelines in this regard shall be followed.
3. The project proponent shall submit within the next 3 months the details on quantification of year wise CER activities along with cost and other details. CER activities must not be less 2% of the project cost. The CER activities should be related to mitigation of Environmental Pollution and awareness for the same.
4. The project proponent shall submit within the next 3 months the details of estimated construction waste generated during the construction period and its management plan.
5. The project proponent shall submit within the next 3 months the details of segregation plan of MSW.
6. The project proponent shall ensure that waste water is properly treated in STP and maximum amount should be reused for gardening flushing system and washing etc. For reuse of water for irrigation sprinkler and drip irrigation system shall be installed and maintained for proper function. Part of the treated sewage, if discharged to sewer line, shall meet the prescribed standards for the discharge.
7. Under any circumstances untreated sewage shall not be discharged to municipal sewer line.
8. The project proponent will ensure that proper dust control arrangements are made during construction and proper display board is installed at the site to inform the public the steps taken to control air pollution as per the Construction and Demolition Waste Management Rules.

9. The project proponent shall install micro solar power plants, toilets in nearby villages, public place or school from CER fund of the project for which E.C is granted in addition to and water harvesting pits and carbon sequestration parks / designed ecosystems.
10. A certificate from Forest Department shall be obtained that no forest land is involved and if forest land is involved the project proponent shall obtain forest clearance and permission of Central and State Government as per the provisions of Forest (conservation) Act, 1980 and submit before the start of work.
11. In compliance to Hon'ble Supreme Court order dated 13/01/2020 in IA no. 158128/2019 and 158129/2019 in Writ petition no. 13029/1985 (MC Mehta Vs GOI and others) anti-smog guns shall be installed to reduce dust during excavation.
12. If the proposed project is situated in notified area of ground water extraction, where creation of new wells for ground water extraction is not allowed, requirement of fresh water shall be met from alternate water sources other than ground water or legally valid source and permission from the competent authority shall be obtained to use it.
13. Provision for charging of electric vehicles as per the guidelines of GoI / GoUP should be submitted within the next 3 months.
14. PP should display EC granted to them on their website. 6-monthly compliance report should be displayed on their website and to be given every six month to residents / occupants of the building.
15. EC is granted with the condition that EC is valid only for the building plan which has been submitted by PP for seeking EC. In case approved building plan is different from the one submitted for seeking EC then this EC will stand null and void.
16. DG sets shall be gas based and Guidelines issued by CAAQMS for NCR region regarding the use of DG sets during construction and operational phase should be followed.

SEIAA noted the comments of SEAC.

SEIAA noted that SEAC has recommended to grant EC to the above project under violation category. SEIAA also gone through legal notice received via email dated 19.04.2023 of Shri Arvind Rai regarding the above project. Hence SEIAA opined to refer back the project to SEAC for review in light of notice received .



3. Common Biomedical Waste Management treatment storage and disposal facility at C-60 UPSIDA Industrial Area, Orai II, District- Jalaun, Dr. Pranjal Patel, M/s Restorehealth Medicare Private Limited., File No. 7677/Proposal No. SIA/UP/INFRA2/420628/2023

SEIAA agreed with the recommendations of SEAC to close/ delist the file as the project proponent did not appear and open only after submission of online request on prescribed online portal.

4. Riverbed "Ordinary Sand Mining" on the riverbed of Yamuna River at Gata No.-706, Village- Kotana Khadar, Tehsil - Baraut, District - Baghpat, M/s Royal Construction Company, Area 12.245 ha., File No. 7678/Proposal No. SIA/UP/MIN/420892/2023

SEIAA agreed with the recommendations of SEAC to close/ delist the file as the project proponent did not appear and open only after submission of online request on prescribed online portal.

5. Production of 2,28,000 MTA Milled Steel Products as MS Strip, MS Beam, MS Angle, MS Channel & Pipe through rolling mill at Plot No. 139 mi, 142, 145 & 146, Village – Dumduma, Tehsil Chunar, Mirzapur, Shri Bhupendra Agrawal, M/s Maa Mahamaya Ispat & Alloys Private Limited., File No. 7680/ 7113/Proposal No. SIA/UP/IND1/419966/2023

SEIAA agreed with the recommendation of SEAC to grant Environmental clearance to the project proposal.

6. "Ordinary Soil Excavation Project" at Gata No. 979, 980, 981, 985, 945, 984 mi, Village- Manikpur Bishu, Tehsil- Etawah, District- Etawah, U.P., Shri Naveen Kumar, Area: 0.8090 Ha., File No. 7683/Proposal No. SIA/UP/MIN/420994/2023

In light of discussion held in SEIAA meeting no. 597 dated 05.05.2022 SEIAA opined to accept the recommendation of SEAC and grant EC to the said project along with all the general and specific conditions as suggested by SEAC but SEIAA replaces the specific condition regarding cluster certificate as "If in future during the progressive mining this lease area becomes part of cluster i.e. area equal to or more than 5 ha., limited to B-1 category, then additional conditions based on the EIA conducted by the concerned lease holders shall be imposed and joint EMP shall be implemented. The lease holder shall mandatorily follow all the imposed conditions otherwise it will amount to violation of E.C. conditions. If the certificate related to cluster provided by the competent authority is found false or incorrect then punitive actions as per the law shall be initiated against the authority issuing the cluster certificate" and adding following conditions:-

1. Validity period of this EC is 3 months from the date of issue as the Lol has been issued for a period of 3 months or co-terminus with the validity of current mine plan or current lease period whichever is earlier. After this period the EC will become null and void.
2. Department of Geology and Mines, Government of Uttar Pradesh and / or concerned district administration, before releasing the security deposit to Project Proponent will ensure that Project Proponent has fully complied with the EC conditions. Non-compliance, if any, should be reported to UPSPCB for appropriate legal action and recovery of compensation.
8. Any application for transfer of this EC, during its validity period unless it is cancelled by a competent authority, has to be necessarily accompanied with status of compliance of EC conditions duly certified by IRO, MoEFCC, GoI, Lucknow.
9. If the air quality deteriorates due to mining, then District Administration & Directorate of Mining should ensure that mining be stopped immediately. Adequate measures be taken for restoring air quality and mining should commence only when air quality attains the prescribed standards.



10. Expansion of Hospital Blocks in the Name of KMC Digital Hospital (Unit of Shanti Foundation for New Medical College under PPP Mode with Govt. of Uttar Pradesh) at Village - Mahuwa & Rudrapur, Tapp-Kathara, Pragana- Haveli, Tehsil- Sadar, Farenda Road, District- Maharajganj, Shri Vinay Kumar Srivastava, M/s Shanti Foundation-Trust., File No. 7462/Proposal No. SIA/UP/INFRA2/411044/2022

SEIAA agreed with the recommendations of the SEAC to grant the prior Environmental Clearance to the proposed project along with all the general and specific conditions as suggested by the SEAC. In addition to the conditions imposed by SEAC the SEIAA added following additional specific conditions:-

- 1- The project proponent shall submit within the next 3 months the details of solar power plant and solar electrification details within the project.
- 2- The project proponent shall ensure to plant broad leaf trees and their maintenance. The CPCB guidelines in this regard shall be followed.
- 3- The project proponent shall submit within the next 3 months the details on quantification of year wise CER activities along with cost and other details. CER activities must not be less 2% of the project cost. The CER activities should be related to mitigation of Environmental Pollution and awareness for the same.
- 4- The project proponent shall submit within the next 3 months the details of estimated construction waste generated during the construction period and its management plan.
- 5- The project proponent shall submit within the next 3 months the details of segregation plan of MSW.
- 6- The project proponent shall ensure that waste water is properly treated in STP and maximum amount should be reused for gardening flushing system and washing etc. For reuse of water for irrigation sprinkler and drip irrigation system shall be installed and maintained for proper function. Part of the treated sewage, if discharged to sewer line, shall meet the prescribed standards for the discharge.
- 7- Under any circumstances untreated sewage shall not be discharged to municipal sewer line.
- 8- The project proponent will ensure that proper dust control arrangements are made during construction and proper display board is installed at the site to inform the public the steps taken to control air pollution as per the Construction and Demolition Waste Management Rules.
- 9- The project proponent shall install micro solar power plants, toilets in nearby villages, public place or school from CER fund of the project for which E.C is granted in addition to and water harvesting pits and carbon sequestration parks / designed ecosystems.
- 10- A certificate from Forest Department shall be obtained that no forest land is involved and if forest land is involved the project proponent shall obtain forest clearance and permission of Central and State Government as per the provisions of Forest (conservation) Act, 1980 and submit before the start of work.
- 11- If the proposed project is situated in notified area of ground water extraction, where creation of new wells for ground water extraction is not allowed, requirement of fresh water shall be met from alternate water sources other than ground water or legally valid source and permission from the competent authority shall be obtained to use it.
