Proposed construction of residential apartment by M/s. Sanklecha Infra Projects Private Limited, & M/s. KLP Projects Ltd.,at SF. No. 273/48 & 274/49, Block. No. 17, Perambur Division, Purasaiwakkam - Perambur Taluk, Chennai District – Seeking Environmental Clearance - Schedule S. No. 8(a) of Category "B2" – Building and Construction projects - Regarding.

The proponent M/s. Sanklecha Infra Projects Private Limited, & M/s. KLP Projects Ltd., has applied for Environment Clearance for the proposed construction of residential project with built-up area of **25569.46 Sq.m.** in the total land area of 13172.722 Sq.m at SF. No. 273/48 & 274/49, Block. No. 17, Perambur Division, Purasaiwakkam - Perambur Taluk, Chennai District.

The Committee observed that the above project comes under Item No 8(a) of the Schedule. After the presentation made by the proponent, the Committee decided to recommend the proposal for the grant of EC to SEIAA after obtaining and considering the following details.

- 1. According to the proposal 173 KLD of treated sewage will be disposed into the CMWSSB sewer. This is a huge quantity which goes as a waste. Hence, the committee suggested that the proponent should attempt to use more of treated sewage for beneficial purposes. Accordingly, the proponent agreed to use 5 KLD of treated sewage for OSR landscaping and 5.5 KLD for lawn maintenance. Thus, the treated sewage that will be disposed into the CMWSSB sewer will come down to 162.5 KLD.
- 2. In the project proposal submitted no details have been furnished regarding the disposal of the used swimming pool water periodically which will happen once in a month. The proponent should furnish details of the disposal method being

planned.

- 3. Regarding the green belt, the following species are recommended:
  - a) Azadirachta indica (Vembu)
  - b) Thespesia populnea (Poovarasu)
  - c) Alstonia scholaris (Ezhilaipalai)
  - d) Mimusops elengi (Magilam)
  - e) Pongamia pinnata (Pungai)
  - f) Terminalia catappa (Badham)
- 4. For CSR activity the portable Gen set and knowledge centre proposed to be donated to the Corporation Higher Secondary School, Perambur at a cost of Rs. 20 Lakhs should be done within 1 year from the commencement of the project. Besides, the amount of Rs. 15Lakhs should be paid to CRRT for restoration and desilting of Otteri Nullah and copy of the receipt should be submitted to SEIAA for the receipt of EC.
