(1) The SEAC in its meeting dated 20-08-2022 recommended for grant of Environmental Clearance for the proposal valid from the date of EC accorded upto the lease period with specific conditions stipulated for sand mine.

(2) Proposal was placed in the meeting of SEIAA held on 30.09.2022 for consideration of EC. The Authority rejected the proposal with opinion that the kml data does not show either the geo-reference of lease area or even the point of the lease area in Parivesh Portal. Accordingly, the application is rejected with request to apply afresh.

(3) The PP has submitted the revised kml and has applied afresh.

(4) The SEAC had already recommended the proposal in SEAC Meeting dated 20-08-2022. Hence, SEAC decided to return this proposal to SEIAA, Odisha as decision will be taken by the SEIAA.
