Petitioner's representation dated 23.09.2021 be considered by SEIAA, Odisha and after issuing notice to the Petitioner and giving her an opportunity of being heard, the same will be disposed of by the SEIAA by a reasoned order not later that 13.12.2021. The decision thereof be communicated to the Petitioner not later than 20.12.2021. The matter was placed in the SEIAA. Odisha meeting held on 09.12.2021 and the petitioner has appeared before SEIAA through her authorized representative Mr. Ameras Kanungo & Mr. Sandip Rajguru. In the meeting the Authority passed a order with direction that the Environmental Scientist and the Environmental Engineer of SEIAA may jointly inspect the impugned area and the two other areas cited in the petition, accompanied by Tahasildar or concerned officers deputed by him to identify the sites; and submit their inspection report on the actual depth of sand deposition at each of the three sites. As per the direction of Authority of Authority myself Pradeept Kumar Nayak, Environmental scientist and Mis Deeptimayee Nayak, Environmental engineer visited the site along with Tahasildar, Kanmtapada and Petitioner and submitted inspection report to SEIAA with the observation that the Simalda sand bed is not in operating condition and no demarcation of lease area has been done that time. As exact lease area is not demarcated so, the exact quantity of sand deposition could not be predicted but as per the peripheral conditions and observation it can be stated that averagely 2.0 meter of sand deposited in the Simalda sand bed area. The average sand deposition of both Trithapada-1 and Trithapada-2 sand bed is around 3.0 meter. After submission of joint inspection report the Authority issued a letter to the Petitioner vide letter no. 3587/SEIAA dated 13.12.2021 with opinion that the concerned Tahasildar shall correctly demarcate the lease area on the ground and make a detailed recheck the depth of sand deposit in the area, and if found necessary, to submit revised Mining Plan for the same. 


