The Authority after detailed discussion and deliberation decided the following:

Also, LoI for inclusion of mineral has expired. Hence, the Authority decided to defer this proposal for submission of valid LoI by Project Proponent and seek clarification from Water Resources Department regarding WRD Certificate submitted by the project proponent regarding status of the applied area w.r.t Hon'ble High court order in Abdul Rehman vs State of Rajasthan.
- 2. Serial No. 2: The proposal was deferred in 5.66th meeting of the Authority for valid NABET certificate and Noise & Vibration study of the area. Now, PP/Consultant has submitted the same. Hence, the Authority decided to grant EC to this proposal.

- 6. Serial No. 25: There is no parity in mining capacity for which ToR was issued by MoEF&CC and capacity for which EC application has been submitted. Also, the mine falls under Aravali hills. SEAC has recommended to close & delist this proposal. Hence, the Authority decided give an opportunity of personal hearing to the project proponent before taking final decision.
- Serial No. 26: The Authority accepted the recommendation of SEAC & decided to close & delist this proposal.
- 8.
