Minutes of the 757th Meeting of the State Level Environment Impact Assessment Authority, UP (SEIAA) held on 14-09-2023

The meeting of 757th State Level Environment Impact Assessment Authority, UP (SEIAA) was held on-line on 14.09.2023 the Directorate of Environment. The following were present in the meeting:-

General discussion -

- 1. SEIAA noted that SEAC imposes the following condition in its MoM:-
 - Project proponent has committed to plant (as per the project) number of trees/hectare. The project proponent/consultant if desires may approach to concerned District Forest Authority to plant (as per the project) trees/ha on a land available to the Forest Department. The project proponent will deposit the required amount for this entire plantation work (including its maintenance and security) to the Forest Department.

SEIAA opined that SEAC may replace this condition as:-

 Project Proponent should submit action plan for carrying out plantation at least @1,000 plants / ha of lease area. In this case, PP should prepare a plan, duly approved either by Forest Department or District plantation committee, for planting at least (as per the project) plants, either on government land or community land, within a periphery of 5 km from the boundary of the lease area along with provisions for maintenance for 5 years. Survival of plants should not be less than the survival rate notified by Uttar Pradesh Forest Department otherwise it will be treated as violation of EC condition.

Further SEIAA opined that Government should be advised to create a "Green Fund" in Department of Forest for contribution by project proponent requiring EC in state regarding plantation required respective to their project.

- SEIAA noted that MoEFCC circular dated 06.05.2022 states that "Green Field" mining project can be issued Standard ToR. Hence to reduce the time taken in granting EC Mining Department U.P. is suggested to include information regarding green field/brown field project while issuing LoI.
- DGM is required to include information regarding green field/brown field project while issuing LoI so that compliance of earlier EC can be ensured.
- SEIAA noted that as per MoEFCC notification S.O. 141(E) dated 15th January, 2016:-The mining of minor minerals is mostly in clusters. The Environment Impact Assessment or Environment Management Plan are required to be prepared for the



entire cluster. The Environment Impact Assessment or Environment Management Plan shall be prepared by the State or State nominated Agency or group of project proponents in the Cluster or the project proponent in the cluster.

Hence Mining Department U.P. is suggested to conduct Environment Impact Assessment or Environment Management Plan for clusters in the State to reduce time taken to grant EC to individual lease area.

SEIAA opined that explosives used in stone mining are as per DGMS specifications or not should be periodically checked by Mining Department U.P.

SEIAA opined that for point no. 1 shall be communicated to SEAC 1&2 and for point no.2, 3, 4,5 a letter in this reference should be send to Mining Department U.P.

- 3- The project proponent shall submit within the next 3 months the details on quantification of year wise CER activities along with cost and other details. In its 689th meeting SEIAA gone through the reply/letter of the project proponent dated 28.12.2022 regarding the above subject and the project proponent was given opportunity for presentation along with the consultant on

03.01.2023 and found that the information provided was as per EIA notification, 2006 (as amended) and hence SEIAA opined that EC issued to_M/s Max-Digi vide letter dated 152/parya/SEAC/4467/ 2019 dated 16.07.2019 will remain operational.

2- Hon'ble NGT Order dated 11.08.2023 in O.A. no. 774/2022 Gaurav Garg Vs. Union of India & Ors. And MA no. 63/2023 regarding Existing Common Bio-Medical Waste Treatment Facility at Subharti Medical College Campus, Subharti Puram, Meerut, Shri Neeraj Aggarwal, M/s Synergy Waste Management Pvt. Ltd., File No. 7761/ Proposal No. SIA/UP/INFRA2/424451/2023.

SEIAA noted that Hon'ble NGT Order dated 11.08.2023 states that:-

... Since the matter is pending before SEIAA, UP thus, the SEIAA is directed to dispose of the application of the applicant as early as possible say within 30 days. In case of absence of any member, the SEIAA may take suitable action and to dispose of the application within the time frame...

SEIAA noted that the above project was taken in its 737th meeting in which SEIAA noted that SEAC has recommended to grant ToR to the above project. SEIAA gone through file and documents and opined that the project proponent shall submit authorization for 150 km radius coverage, ground water permission, details of 4788 health care unit like districts, no. of beds etc., only site coordinate given, geo-coordinate of the area should be submitted. The project proponent has submitted his reply vide letter dated 28.06.2023. SEIAA also gone through the letter dated 21.08.2023 of Shri Vijay Kumar, Delhi and Shri and Rajeev Shinghal letter dated 13.06.2023 regarding the complaint of the above project along with letter of GoUP no. 631/81-6-2022 dated 28.06.2023. Hence SEIAA opined that the complaint received, letter of project proponent dated 28.06.2023 and letter dated 28.06.2023 shall be referred to SEAC to review the case in light of NGT judgment dated 31.07.2023 in O.A. no. 622 of 2022.

3- "Ordinary Soil Excavation" Project at Gata No.- 1581, 1583, 1578 & 1507, Village-Akrauli, Tehsil- Chandausi & District- Sambhal, Shri Phool Prakash, Area- 2.248 Ha., 7783/SIA/ UP/MIN/426095/2023.

SEIAA gone through the letter dated 01.09.2023 of the project proponent regarding extension of EC granted on 02.06.2023 for 10 days due to hindrance in transportation route because of festivals. SEIAA opined that the above letter shall be sent to SEAC for necessary action.

- 4- (i) Expansion of Group Housing Project "The Vasundhara Grand" at Plot no. 15/Commercial-02, Vasundhara, District- Ghaziabad, Uttar Pradesh, M/s Nandini Build Home Consortium Pvt. Ltd, File No. 7207/Proposal No. SIA/UP/MIS/781413/2022 (ii) Letter of GoUP dated 19.06.2023 regarding complaint dated 13.06.2023 of Shri Arvind Rai of the above project.
 - SEIAA noted that the above project was taken in its 655th meeting in which SEIAA opined that:-
 - a) PP / consultant to submit compliance report through IRO, MoEFCC, GoI, Lucknow of existing EC, if any, granted to the project
 - b) PP / consultant to submit compliance report through UPPCB of existing CtE and CtO.
 - c) PP to submit details of expenditure made beyond the sanctioned EC, if any, issued / verified either by UP RERA or UP Housing and Development Board or GDA or any other competent Government body in light of MoEFCC, Gol OM OM dated



- 07.07.2022. SEAC-1 to examine the document and submit their recommendation to SEIAA.
- d) PP / consultant to submit point-wise compliance, in a tabular form, of MoEFCC, GoI OM no. 22-21/2020-IA.III dated 07.07.2021 (SoP for identification and handling of violation cases under EIA Notification 2006).

The project proponent has submitted his reply vide undated letter received in office on 13.06.2023 along with cost estimation certificate by Chartered Engineer and CCR from IRO, MoEFCC

SEIAA agreed with the recommendation of SEAC to issue ToR to the above project adding following points:-

- Penalty of Rs. 9,11,750/- (Rupees Nine lakhs eleven thousands seven hundred and fifty only) (1% of total project cost incurred as per chartered Engineer certificate) has to be deposited on project proponent which with UPPCB before filling of EIA Report.
- Further, SEIAA added that without prejudice to any other consequences, action to be initiated u/s 15 read with section-19 of EPA, 1986 against the PP and Project to be closed until EC is granted.
- The State Government/SPCB to take action against the project proponent under the provisions of the Environment (Protection) Act, 1986, and further no consent to operate to be issued till the project is granted EC.
- Direction to be issued under section 5 of the Environment (Protection) Act, 1986 to stop the violating activities till the EC is obtained.
- 5. The project proponent shall be required to submit a bank guarantee equivalent to the amount of remediation plan and natural and community resource augmentation plan with the SPCB prior to the grant of EC. The quantum shall be recommended by the EAC and finalized by the regulatory authority. The bank guarantee shall be released after successful implementation of the EMP, followed by recommendations of the EAC and approval of the regulatory authority.
- Assessment of ecological damage with respect to air, water, land and other
 environmental attributes. The collection and analysis of data shall be done by an
 environmental laboratory duly notified under the Environment (Protection) Act,
 1986, or an environmental laboratory accredited by NABL, or a laboratory of a
 Council of Scientific and Industrial Research (CSIR).
- Preparation of EMP comprising remediation plan and natural and community resource augmentation plan corresponding to the ecological damage assessed and economic benefits derived due to violation.
- The remediation plan and the natural and community resource augmentation plan to be prepared as an independent chapter (13) in the EIA report by the accredited consultants.
- Budget of remediation plan and natural and community resource augmentation plan corresponding to the ecological damage shall be completed within three years and to be prepared accordingly.
- All pages of technical documents/EIA/EMP etc. should be signed by the consultant and project proponent both.
- Copy of all the analysis reports duly signed by analyst approved by NABL or MoEF&CC shall be annexed with the EIA report and original analysis reports should be presented at the time of presentation.
- MOU signed between the project proponent and the consultant should be submitted.

- 13. A certificate from Forest Department shall be obtained that no forest land is involved and if forest land is involved the project proponent shall obtain the forest clearance and permission of Central and State Government as per law under the provisions of Forest (conservation) Act, 1980 and submit along with EIA.
- Provision for charging of electric vehicles as per the guidelines of GoI / GoUP should be submitted.
- SEIAA opined that the project proponent shall submit permission of CGWA or proposal for alternative source of fresh water.
- 16. A letter shall be send to DM Ghaziabad, VC GDA and MS, SPCB to ensure that no construction is started until valid EC is obtained and in case construction has been carried out without valid EC then work should be stopped and legal action should be initiated against the PP.
- SEIAA opined that the complaint of Shri Arvind Rai dated 13.06.2023 shall be refer back to SEAC for necessary action.
