The chronology of the developments of this project M/s. Srini Rocks are as follows:

During the month of March-2015, the proponent M/s. Srini Rocks approached the committee for issue of EC, whose area is falling within 5 kilometers from the State boundary. The Committee examined the case in the light of Notification of Ministry of Environment, Forests and Climate Change S.O. 2601 (E) dated 07.10.2014. Since the Committee could not arrive at a unified opinion due to different interpretational wisdoms, it was referred for the legal opinion during March-2015.

Subsequent to the receipt of the Legal opinion, the Committee discussed the matter at length and resolved to adopt with reference to calculation of total area of mining falling under category of mining issued with EC &mining without EC the following recommendations.

- 1. To obtain following details in respect of mines situated within 5 kilometers from the State boundary.
  - a. The total mining leases accorded in the said area,
  - b. To get the extent of the areas that were already having Environmental Clearance,
  - c. The operating mining leases that do not have Environmental Clearances.

2. To calculate the total area of mining projects that have EC and if such total including that of the project under consideration exceeds 5 (five) hectares, the case does not come under the purview of SEAC. In case, the above total area is less than or equal to 5 hectares, the case be taken up by the Committee depending on the merits of the case.

- 2. To inform as 'Sumoto' to all the earlier proponents who fall under such category, and deal the cases based on their merits accordingly.
- 3. To inform as 'Sumoto' to all the earlier proponents who fall under such category, and deal the cases based on their merits.

Hence in View of the above resolutions, the committee recommended for issue of EC for this project duly incorporating the other stipulated conditions.
